

RESOLUTION NO. 143-2016

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, the County of El Dorado Board of Supervisors is authorized to adopt new fees, fee levels, and charges, pursuant to Government Code § 54985; and

WHEREAS, the County of El Dorado has reviewed and analyzed the current Animal Services fee structure established via Resolution 025-2011; and

WHEREAS, the County, having completed said analysis which included a review of Animal Services operations (personnel, indirect and overhead, supervision and equipment costs) and a full cost recovery analysis, as well as comparison against prevailing fees charged in surrounding counties, as applicable; and

WHEREAS, the County has determined that on occasion, extenuating circumstances may require that certain of the fees outlined hereto be waived, discounted, or deferred, and that the County Chief Animal Control Officer shall be empowered to take such action when it is deemed to be in the best interest of the animal; and

NOW, THEREFORE, BE IT RESOLVED that effective October 1, 2016, Board Resolution No. 025-2011 is hereby replaced by this Resolution, and the fees, fee levels, and charges attached hereto as Exhibit A "Animal Services Fees" shall be implemented.
