

Dear Planning Commissioners:

The Buckeye Union School District operates Camerado Springs Middle School and Blue Oak Elementary School, both of which are off Country Club Drive adjacent to the Bass Lake Hills Specific Plan. The District also owns a future school site within the Bass Lake Hills Specific Plan. Traffic leaving our schools in the morning backs up at Country Club and Bass Lake Road. This creates potentially unsafe conditions at this intersection.

The District supports the revised Conditions of Approval for the three tentative maps, Bell Woods, Bell Ranch and Hawk View. It is my understanding that the tentative maps are now conditioned to construct Country Club Drive (Tierra De Dios) from its terminus near the Holy Trinity Church to Bass Lake Road as part of El Dorado County's CIP/TIM fee program. Additionally, the Bass Lake Road/Country Club intersection will become signalized. The realignment of Country Club Drive will enhance the safety of our parents after they drop their children off at school and travel to Bass Lake Road and Highway 50. We urge you to approve these revisions so Country Club can be realigned as soon as possible.
