## AGREEMENT FOR SERVICES #469-S1510 AMENDMENT I

This Amendment I to that Agreement for Services #469-S1510, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and BI Incorporated, a Colorado Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 6265 Gunbarrel Avenue, Suite B, Boulder CO, 80301 and whose Agent for Service of Process is *Corporate Creations Network, Inc., 1430 Truxtun Ave. 5th Fl., Bakersfield, CA 93301*; (hereinafter referred to as "Contractor");

#### **RECITALS**

WHEREAS, Contractor has been engaged by County to provide electronic home monitoring, Global Positioning System (GPS) tracking, and alcohol monitoring equipment and monitoring services on an "as-requested" basis for the Probation Department, in accordance with Agreement for Services #469-S1510, dated July 30, 2015, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase the not to exceed amount of said Agreement by an additional \$20,000, hereby amending ARTICLE III Compensation for Services; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #469-S1510 shall be amended a first time as follows:

#### **ARTICLE III**

Compensation for Services: For services provided herein, County agrees to pay Contractor monthly in arrears and within forty five (45) days following the County's receipt and approval of itemized invoice(s) identifying services rendered. For the purposes of this Agreement, the billing rate shall be in accordance with "Exhibit A, ELECTRONIC MONITORING SERVICE AGREEMENT - U.S. COMMUNITIES No. 032515VG1"

As authorized by the Chief Probation Officer, travel expenses, as-need for on-site training only, shall be reimbursed in accordance with "Exhibit B, Board of Supervisors Policy D-1," incorporated herein and made by reference a part hereof.

Total amount of this Agreement shall not exceed \$83,000.00.

Except as herein amended, all other parts and sections of that Agreement #469-S1510 shall remain unchanged and in full force and effect.
