- EDC public survey asked for more transparency and communication from LE – letting taxpayers know what we do.
- Need for extreme confidentiality for other departments PIO gives up too much info. (Consequence of mistake - criminals go free, victims rights violated) And, Early drafts contain sensitive info.
- Pub def / other agencies using same PIO? Conflict. On occasion we are prosecuting/investigating other agencies represented by county PIO... For instance Brown act, and Phillip Garrido - represented by PD.
- Need for all hours availability.
- It's a team consisting of 2 investigators, one secretary and 2 attorneys that aggregate and gather information

DA PIO Consulting Contract

- Protection of public and victims... re updates on most wanted... tips for cold cases, and resolution of criminal cases (not just up to arrest).
- Protection of elder and scam victims by outreach.
- Impact on citizens and victims of consequential changes in criminal law in California.
- PIO consultant good for clearer message and coalescing various information sources into outreach to community.
- Sheriff has one for same reasons.

Power of a false narrative on the internet

- Known as the "Ferguson effect," the phenomenon appears connected to the events in August of 2014, in Ferguson, Missouri.
- The effect is a product of a false narrative repeated over and over again without any official response.
- In Ferguson, a police officer shot and killed Michael Brown after a reported strong arm robbery
- By August 11, 2014, The New Yorker's, Amy Davidson had posted an article highlighting protesters with their hands in the air chanting, "Don't shoot me."
- The article laments the shooting of an "eighteen year old running away from the officer, not towards him."
- That same day the Wall Street Journal posted a story commencing with "Hands up don't shoot."
- Also on August 11, Time magazine posted a similar narrative characterizing Brown as a "gentle giant."

False Narrative Proven Wrong


 Autopsy results and bullet trajectory, skin from Brown's palm on the outside of the SUV door as well as Brown's DNA on the inside of the driver's door the SUV door as well as Brown's DNA on the inside of the driver's door corroborate Wilson's account that during the struggle, Brown used his right hand to grab and attempt to control Wilson's gun. According to three autopsies, Brown sustained a close range gunshot wound to the fleshy portion of his right hand at the base of his right thumb. Soot from the muzzle of the gun found embedded in the tissue of this wound coupled with indicia of thermal change from the heat of the muzzle indicate that Brown's hand was within inches of the muzzle of Wilson's gun when it was fired. The location of the recovered bullet in the side panel of the driver's door, just above Wilson's lap, also corroborates Wilson's account of the struggle over the gun and when the gun was fired, as do witness accounts that Wilson fired at least one shot from inside the SUV
