Please don't expand White Rock Road to a 4 Iane highway. It will ruin the quality of life we have here. We do not want this area to turn into the Bay Area.



To Whom it May concern:

There is concern within the Four Seasons Community that with the widening of White Rock Road and your approval of diverting a portion of the truck and car traffic and installing a traffic light at Carson Crossing, our quality of life of will be destroyed and the value of our homes will be reduced.

The widening of White Rock Road has some fundamental issues that have not been adequately addressed in the present development of the project including:

- Traffic ADT Average Daily Traffic does the ADT average daily traffic support the 4 -lanes, what is the LOS level of service,
- Traffic Signals What is placement of traffic signals being proposed/located; with the NEW Lennar development how does that influx of traffic access White Rock;
- Environmental The noise analysis study does not appear to address the noise impacts per CEQA/NEPA (per Caltrans Noise Policy from top of large trucks smoke stack to receptor (5.5 ft person) the line of sight must be broken to reduce the sound as the existing Four Season sound walls appear to need additional height to meet this requirement);
- Bicycle Route Is the bicycle route part of an approved larger county wide route;
- ADA American Disabilities Act Is it properly addressed (sidewalks, curb cuts, etc.); with the congestion that already occurs at White Rock and Latrobe (especially during AM & PM rush hours) what traffic mitigation is being proposed;
- ADT Corridor Traffic How does allowing large trucks use the route effect the traffic and related congestion management requirements (LOS, air conformity, etc.);
  - Was a destination trip for Grant Line / HWY 99 to Prairie City Road / HWY 50 and/or White Rock/Latrobe/Hwy 50 done (IE: identifying the shortest route from point A to point B for traffic (including large trucks);
- Funding Are Federal-aid dollars being used on this project and/or any part of GrantLine extension (possible environmental segmentation);


