Charter Review Committee Update October 10, 2017, BOS Agenda Item #34

- 1. This is an update of the Charter Review Committee efforts;
- 2. It is an update only and we are not seeking any action by the BOS today;
- 3. As the Chair, I applaud the BOS for its Committee member selections. We are diverse in opinion and therefore do not always agree. But, we are thorough and transparent as you would expect of us and work well together;
- 4. As you are aware, we are advisory only. The process explained is Charter review, approval/rejection on all changes considered, forwarding our approvals to you for consideration, and if you agree, the proposed Charter change is forwarded to the voters for their consideration on the next available election;

- The Charter Review Committee has met to date 7 times, starting on June
 21st and completing its 7th meeting on October 5th;
- 6. We have established our business record by taking the 2015-2016 Grand Jury Recommendations in order starting with Recommendation #1;
- 7. Our review is built on a pattern of reading the recommendation, having an initial Committee discussion, seeking public input, continuing Committee discussion including possible County Counsel input, then to act (to approve or reject)/or continue the item to gather addition information;
- 8. If we approve the Grand Jury Recommendation, we will then forward these approvals to you for your action at a future date once our work is complete.
 If we reject, the Charter provisions remain the same unless an amendment is offered by a Committee member. If the amendment is approved, then it also will be forwarded for your action;

9. The Charter Review actions as of today are the following:

Charter Review Committee has approved, as is or amended, 2 Grand Jury

Recommendations and rejected 5 Grand Jury Recommendations of the first

for Resolution and your action, on an agenized date, and with final public

input before possible advancement to the voters; and
