<u>Adult Protective Services (APS)</u>

The goal of the APS Program is to to support the health and safety of the elder and dependent adults we serve, be a resource for families and community supports and provide community education regarding the identification and prevention of adult abuse and neglect.

Adult Protective Services (APS) is a State-mandated program through the California Department of Social Services to help elder (65 years and older) and dependent adults (18 – 64 who are disabled) who are unable to meet their own needs or are victims of abuse, neglect or exploitation. APS serves individuals residing in private homes, apartments, hotels or hospitals. The primary types of abuse and neglect include: physical abuse, sexual abuse or assault, isolation, abandonment, abduction, financial abuse, neglect (including self-neglect).

APS receives calls from people who are requesting help for themselves or for someone else. With the client's consent, an APS Social Worker assesses the situation to work towards a positive resolution. Services provided include: comprehensive assessment, emergency services, time limited case management, linkage to county and community services and resources, advocacy and education.

APS Statistics:

During FY 16/17, APS received over 1200 referrals of elder and dependent adult abuse, neglect and exploitation. Approximately 69% of referrals received are regarding elders and 31% are for dependent adults.

Cross reporting APS agencies, law enforcement agencies and the Office of the State Long-Term Care Ombudsman (OSLTCO) have the responsibility to cross-report allegations of abuse to the appropriate law enforcement agencies, public agencies, and licensing entities having jurisdiction over these cases. These agencies include:

- The California Department of Health Services (DHCS), Licensing & Certification, handles cases of alleged abuse by a member of a hospital or health clinic. County APS staff evaluates abuse cases and arranges for services such as advocacy, counseling, money management, out-of-home placement, or conservatorship.
- The Office of the State Long Term Care Ombudsman (OSLTCO), administered by the California Department of Aging (CDA), has jurisdiction for investigating reports of abuse that occur in nursing homes, residential care facilities for the elderly, adult residential facilities, intermediate care facilities, adult day health care facilities, and adult day programs.
- The California Department of State Hospitals has jurisdiction for investigating reports of alleged abuse at California State Mental Hospitals.
- The California Department of Developmental Services (CDDS) has jurisdiction to investigate reports of alleged abuse that occur at State Developmental Centers.

Elder and Dependent Adult Abuse Project (EDAAP)

In September 2016, El Dorado County was awarded a \$400,000 grant under the Federal Victims of Crime Act (VOCA) through the California Office of Emergency Services (Cal OES). The project was designed to enhance collaboration between the County's Adult Protective Services, Senior Legal Services and the District Attorney's office with the following objectives:

- Provide and coordinate direct services for elder and dependent adult victims of crime
- Expand community capacity to serve victims
- Ensure victims have access to the criminal justice system via court navigation and support services
- Bridge the gap between elder justice services providers and victim service providers
- Implement an outreach awareness program for elders and dependent adults, victims of crimes, mandated reporters and the broader community

The project partnered an APS Social Worker with a Victim Witness Program Specialist to facilitate services between the entities. The Victim Witness services include: direct services to crime victims, navigation of the stages of criminal prosecution, ensuring victims understand their rights and the services and supports available to them; crisis counseling, emergency assistance, court support and restitution assistance.

The project also includes coordination of a Multidisciplinary Team to enhance community wide collaboration, education and to evaluate the protective services provided in the County; as well as some funds for emergency services.

In-Home Supportive Services (IHSS)

An Alternative to Out-Of-Home Care

IHSS is a program that provides services to individuals on a limited income who need assistance to remain living in their own homes and communities. IHSS is an alternative to out of home care, providing domestic and personal care services to eligible IHSS recipients.

IHSS Basic Eligibility

- 65 years old, blind or disabled
- Receive SSI or are low income with low assets
- You are a U.S. citizen or Legal Permanent Resident
- Live in a private residence
- Eligible to receive Medi-Cal

Note: There are specific eligibility requirements when a recipient has a spouse or is a child.

IHSS recipients may receive personal care services such as bathing, grooming, dressing and toileting as well as domestic services such as cleaning, meal preparation, shopping and laundry. Services are authorized based on the individual functional needs and in accordance with program regulations.

The IHSS recipient is the employer of the care provider. IHSS will arrange payment once the APS/EDAAP/IHSS/MSSP-Fact Sheet 9.25.17 (Ikw)

care provider is hired by the recipient. The recipient is responsible for providing supervision and signing the provider's time sheets. Family and friends are encouraged to help in locating a provider. Relatives may be the care provider.

IHSS Statistics

IHSS has a current caseload of 1309 client's including pending cases (83); 587 clients are male and 722 are female.
