Among other things, the oaks create habitat for native birds, animals, and understory plants. They also create a landscape we residents value for its beauty and serenity. Allowing unfettered destruction of this resource is against the best interests of the residents of this county.

The "mitigation" measures fail the logic test. How can planting oak seedlings or acorns on property miles away be any kind of replacement for the oak woodlands in your own neighborhood?! The same goes for in lieu payments to buy conservation easements miles away.
