Please advise the Board of Supervisors that I support the repeal of Prop 90 within our county despite my affiliation with an industry that generally supports this proposition. I do not support it for the following reasons:

- 1) Simple economic theory is supply and demand dictates market value. We have very limited supply of homes in this county and therefore do not need to offer incentives to attract additional buyers. Supply is our problem not demand!
- 2) Reduced property tax values hinder the county's ability to meet its future financial obligations.
- 3) Attracting seniors not paying their fair share of property taxes as their neighbors is a subsidy that can be easily avoided.
- 4) Demands on county services far out way any perceived benefit promoted by the self-interest of the real estate industry.

Senior and affordable housing are certainly needed within this county and in my opinion, Prop 90 is far more harmful to addressing these needs than most want to believe. Please repeal Prop 90 for the benefit of all county residents and business owners.
