SUMMARY OF ORDINANCE NO. 5061

AN ORDINANCE ADOPTING CHAPTER 130.39
(OAK RESOURCES CONSERVATION)
OF TITLE 130 (ZONING ORDINANCE)

THE BOARD OF SUPERVISORS OF THE COUNTY
OF EL DORADO DOES ORDAIN AS FOLLOWS:

Ordinance 5061 is Chapter 130.39 (Oak Resources Conservation) of the County's existing Zoning Ordinance (Title 130 of the El Dorado County Code of Ordinances). The ordinance shall establish standards for implementing the County's Oak Resources Management Plan (ORMP) (including the in-lieu fee payment option) in compliance with General Plan Policy 7.4.4.4 and Implementation Measure CO-P (mitigation requirements for impacts to oak resources). This Chapter shall be referred to as the Oak Resources Conservation Ordinance ("Ordinance"). The Ordinance applies to both ministerial and discretionary development resulting in impacts to Oak Resources (oak woodlands, individual native oak trees and Heritage Trees) as defined in this Chapter. This Chapter shall apply to all privately-owned lands within the unincorporated area of the County at or below the elevation of 4,000 feet above sea level where Oak Resources are present. The Ordinance includes the following sections: Content; Applicability; Definitions; Prohibition; Exemptions and Mitigation Reductions; Oak Tree and Oak Woodland Removal Permits - Ministerial Development Projects; Oak Tree and Oak Woodland Removal Permits - Discretionary Development Projects; In-Lieu Fee Appeals; Enforcement; and Mitigation Maintenance, Monitoring and Reporting.
