



**RESOLUTION NO. 204-2016**  
**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**  
**SOUTH TAHOE REFUSE CO., INC.**  
**AREA A**  
**SCHEDULE OF RATES**

**WHEREAS**, County Ordinance section 8.42.150 provides that the Board of Supervisors shall set the rates to be charged by a franchisee at such times as the Board deems appropriate; and

**WHEREAS**, pursuant to County Ordinance section 8.42.170, the franchisee has provided written notice to each ratepayer of the proposed adjustment in a form approved by the County of the time, date, and place of the public hearing to set rates and the notice was provided at least ten but no more than sixty days before the public hearing; and

**WHEREAS**, pursuant to County Ordinance section 8.42.170, notice of the time, place, and purpose of the public hearing has been published in a newspaper of general circulation printed and published in the County, once each week, for two consecutive weeks prior to such hearing; and

**WHEREAS**, a public hearing was held on December 13, 2016, for the purpose of adjusting solid waste collection rates within South Tahoe Refuse, Franchise Area A; and

**WHEREAS**, the South Tahoe Refuse, Franchise Area A, solid waste collection rates shall have a one (1) and 62/100 percent (1.62%) increase effective January 1, 2017.

**NOW, THEREFORE**, be it resolved that effective January 1, 2017, the following rates are adjusted upward 1.62% for the collection of solid waste within the South Tahoe Refuse Co., Inc., Area A:
