

## RESOLUTION NO. 081-2017

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DECLARING THE BOARD'S INTENT TO LEASE COUNTY-OWNED BUILDING LOCATED AT 542 MAIN STREET, PLACERVILLE (APN #003-141-07)

WHEREAS, the County of El Dorado is the owner of certain real property at 542 Main Street (APN #003-141-07) in the City of Placerville, California of approximately three thousand eight hundred forth (3,840) square feet of improved office space and common parking areas (the "Property"); and

WHEREAS, the County is authorized to lease real property owned by the County for commercial use pursuant to Government Code sections 25515 through 25515.5; and

**WHEREAS**, the terms upon which the County will lease the Property in "as is" condition are further set forth in the "Request for Proposals #17-946-049 for Lease of County Property" (RFP).

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of El Dorado does hereby declare its intention to lease the Property for public or commercial purposes, and authorize the release of the RFP; and

**BE IT RESOLVED**, that the Board will receive written proposals, if any, for the Lease of the Property at the Board's regular meeting on Tuesday, July 18, 2017 at 10:00 a.m. or as soon thereafter as can be heard subject to the following terms:

WRITTEN PROPOSALS DUE: Tuesday, July 18, 2017 by 10:00 a.m.

**TENANT:** Must be a public agency, or non-profit organization that qualifies for tax-exempt status pursuant to IRS Code Section 501(c).
