OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Resolution Adopting the 2011 Revisions to the County of El Dorado Maintained Mileage System

WHEREAS, the Board of Supervisors of the County of El Dorado has general supervision, management and control of the county highways as provided in Section 941 and Section 2121 of the California Streets and Highways Code;

WHEREAS, the Board of Supervisors, by proper order, causes those highways, which are necessary to public convenience to be established, recorded, constructed, and maintained;

WHEREAS, no public or private road can become a county highway until and unless the Board of Supervisors, or its designee, by appropriate action, has caused the road to be accepted into the County Maintained Mileage System.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of El Dorado hereby adopts the 2011 revisions from the 2010 Maintained Mileage of 1,077.52 maintained miles to 1,079.17 miles to the County of El Dorado Maintained Mileage System for 2011, as shown on Attachment A.
