

RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

REPLACING RESOLUTION #269-2009

WHEREAS, salaries for classifications in Sheriff's Management, Deputy Sheriff and Sheriff's Sergeant are determined by Section 504 of the El Dorado County Charter; and

WHEREAS, classifications of Investigator (D.A.), Senior Investigator (D.A.), Supervising Investigator (D.A.), Chief Investigator (D.A.), Senior Investigator (Public Defender), Sheriff and specified Sheriff's Management classifications are entitled to commensurate increases per Salary and Benefits Resolution Section 704, Resolution #227-99, and Memorandum of Understanding; and

WHEREAS, the Board of Supervisors previously approved Resolution #269-2009, which incorporated salary increases in accordance with El Dorado County Charter Section 504, Section 704 of the Salary & Benefits Resolution #227-99, and Memorandum of Understanding; and

WHEREAS, the County has notified employee representatives of the indicated salary adjustments; and

WHEREAS, certain rounding errors in the calculation of salary rates in Resolution #269-2009 require correction;

NOW, THEREFORE, BE IT RESOLVED, that this resolution shall amend and replace Resolution #269-2009 and establish the following salary ranges for covered classifications, effective January 2, 2010.
