- (5) Northeasterly along the arc of said curve through a central angle of 01°01'15", an arc distance of 29.43 feet (said curve being subtended by a chord that bears North 41°48'59" East 29.43 feet) to a three-quarter (3/4") inch capped iron pipe stamped "L.S. 4434-1984" in the Southeasterly side of Mother Lode Drive; thence,
- (6) Northeasterly along the Southeasterly side of Mother Lode Drive, North 65°29'30" East 146.91 feet to a three-quarter (3/4") inch capped iron pipe stamped "L.S. 4434-1984"; thence,
- (7) leaving the Southeasterly side of Mother Lode Drive, South 24°30'30" East 108.00 fee to a three-quarter (3/4") inch capped iron pipe stamped "L.S. 4434-1984"; thence,
- (8) North 65°29'30" East 108.03 feet to a three-quarter (3/4") inch capped iron pipe stamped "L.S. 4434-1984" in the Southwesterly side of French Creek Road, the beginning of a nontangent curve to the Left with a radius of 230.00 feet, concave to the Northeast, the radial to which bears South 77°23'28" West; thence,

- (9) Southeasterly along the Southwesterly side of said French Creek Road and the arc of said curve through a central angle of 28°26'12", an arc distance of 114.15 feet (said curve being subtended by a chord that bears South 26°49'38" East 112.98) to a three-quarter (3/4") inch capped iron pipe stamped "RCE 20462"; thence,
- (10) leaving the Southwesterly side of said French Creek Road, North 48°57'08" East 59.22 feet to the Northeasterly side of said French Creek Road; thence,
- (11) Southeasterly along the Northeasterly side of said French Creek Road, South 41°16'55" East 42.89 feet to the East line of said Section 1; thence,
- (12) Southerly along the East line of said Section 1; South 00°34'26" West 46.34 feet to the most Northerly point in the boundary of Parcel 1, as shown and so designated on Parcel Map that filed for record in the Office of the El Dorado County Recorder on August 25, 1983, in Book 32 of Parcel Maps at Page 40; thence,
- (13) leaving the East line of Section 1, Southeasterly along the Northeasterly boundary of said Parcel 1, South 37°47'05" East 256.97 feet (shown as South 37°41'20" East 261.76 feet) to the Northeasterly corner of Parcel A, as said parcel is shown and so designated on that Parcel Map that filed for record in the Office of the El Dorado County Recorder on March 9, 2005, in Book 48 of Parcel Maps at Page 144; thence,
- (14) Southeasterly along the Northeasterly boundary of said Parcel A, South 23°50'40" East 133.35 feet to the most Northerly point in the boundary of Parcel 3 of that Parcel Map that filed for record in the Office of the El Dorado County Recorder on August 25, 1983, in Book 32 of Parcel Maps at Page 40; thence, Southeasterly along the boundary of said Parcel 3,
- (15) South 23°50'40" East (shown as South 23°44'55" East) 157.38 feet; thence,
- (16) South 23°23'55" East 166.58 feet (shown as South 23°18'10" East 166.11 feet); thence,
- (17) South 12°17'30" East 27.85 feet (shown as South 12°22' East 28.33 feet) to the Southeasterly corner of said Parcel 3; thence,
- (18) Westerly along the Southerly boundary of said Parcel 3, South 86°08'11" West 175.51 feet to a three-quarter (3/4") inch capped iron pipe stamped "L.S. 4434-1983" at the Southwesterly corner of said Parcel 3 and in the Easterly boundary of the aforesaid Parcel A; thence, along the boundary of the aforesaid Parcel A,
- (19) South 86°08'11" West 71.93 feet to a three-quarter (3/4") inch capped iron pipe stamped "RCE 20462-2004"; thence,
- (20) South 00°06'50" West 189.69 feet to a three-quarter (3/4") inch capped iron pipe stamped "RCE 20462-2004"; thence
- (21) South 89°58'41" West 108.38 feet to the point of beginning,
