**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**RESOLUTION ESTABLISHING BENEFIT ASSESSMENT  
FOR AMBULANCE SERVICES IN  
COUNTY SERVICE AREA No. 3 SOUTH SHORE AREA  
FOR FISCAL YEAR 2007/2008**

WHEREAS, the Board of Supervisors of El Dorado County has authorized County Service Area No. 3 to provide ambulance services pursuant to Section 25210.4 of the Government Code to provide ambulance services in County Service Area No. 3; and

WHEREAS, the Board of Supervisors of El Dorado County, acting as the governing board for County Service Area No. 3, has caused a written engineer's report to be prepared determining the proportionate special benefit to each property to be assessed in relation to the entirety of the cost of the services, a copy of which is on file at the Office of the Clerk of the Board of Supervisors at 330 Fair Lane, Placerville, California, pursuant to the passage of Proposition 218 and the provisions of Article XIII D of the California Constitution; and

WHEREAS, the Board of Supervisors of El Dorado County held assessment ballot proceedings, including a duly noticed public hearing, in accordance with Article XIII D of the California constitution; and

WHEREAS, the Board of Supervisors of El Dorado County finds that a Benefit Assessment based upon the proportionate special benefit identified within County Service Area No. 3 is the appropriate way to apportion a part of the cost of providing ambulance services in accordance with the benefits to be conferred in said area; and

WHEREAS, all notices required by law have been duly given;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of El Dorado that the following assessment be levied on each and every improved parcel identified and located within the boundaries of county Service Area No. 3, except for the "Tahoe West Shore Zone of Benefit", as based upon the Benefit Assessment formula attached hereto and incorporated as Attachment A; and

BE IT FURTHER RESOLVED that the assessment, as adopted and confirmed herein, shall appear as a separate item on the tax bill of each such improved parcel and shall be collected at the same time and in the same manner as ordinary county ad valorem property taxes are collected as more specifically set forth and authorized in subdivision (d) of Section 25210.77a and Section 25210.8 of the Government Code; and

BE IT FURTHER RESOLVED that the Clerk of the Board of Supervisors is hereby authorized and directed to transmit copies of this resolution to the El Dorado County Assessor, Auditor-Controller, and Treasurer and Tax Collector for implementation as authorized by law; and

BE IT FURTHER RESOLVED that this Resolution shall be recorded and filed with the State Board of Equalization.
