



I read today a letter that Brandi Peerman sent to the planning department and I am astounded at the untruths that she wrote in her letter.

She states that the cell tower is 50 feet from her home. That is totally untrue. Brandi's husband Steve and I last year measured from the tower site to her property line which was 750'. Steve stated to me that he had already measured from the property line to the house and it was an additional 550'.

She claims but because the power is so close to her home her children will be able to easily climb up the tower and get injured. This is untrue.

Between my property line and her property line is a wooded 4 acre parcel and even then my tower is on the eastern section of my property. Additionally I have a 6 foot high deer fence surrounding the upper acerage.

She claims that some sheep on her farm would be disrupted by the noise from the tower but at least once a week they target practice with their firearms on their property and their son rides a dirt bike on the road in front of their house. I am referring to all of this because her letter is filled with untruths and misrepresenting the facts.

Since the very beginning of when I excepted AT&T's offer to put a tower on my property I have received nothing but grief from the Peerman's.

I want to invite any individual in the planning department or the planning commissioners to my property and see where the cell tower site is located at.

You would see that no one except for one home will be able to see the tower and that home is not the Peerman's.

I do not know what to expect on January 11th at the meeting at 8:30 AM from Brandi Peerman but I would suspect that she has fired up her base by her Facebook posting and probably your office will be inundated with more emails and the meeting on the 11th could have a lot of people at the meeting opposing the tower who do not even live in our area. Hello community, we are the Peerman family. We are reaching out to you on behalf of our family, our neighbors, and our community to ask for your help protecting our children, our family farms, our homes, and our financial futures. We live in a rural residential area on a 30 acre solar powered organic farm in Placerville CA. Together we own and operate a real estate brokerage and homeschool our children from our farm. We moved to the country to raise our children and run our family business in a quiet and peaceful environment. Our house is much more than just a home. Our family farm is very important to us. Our farm is in a remote area that is very quiet and peaceful. It is a place of healing. We raise several breeds of critically endangered animals. These sensitive animals need to live in a safe place away from the noise and disturbances of the city. Our farm is also a wildlife habitat. Our habitats provide a safe environment where these animals can thrive.

Our neighbors organic farm, Peaceful Mountain Farm, participates in the conservation efforts of several endangered animals. Peaceful Mountain Sanctuary is owned by a kind hearted family that has a portion of their farm that they use for an endangered animal sanctuary where they care for these precious animals who have no other place to go. Their habitats provide a safe environment where these animals can thrive.

One of our neighbors has signed a contract with a telecommunications company to put in an industrial telecommunications facility and a 160 Ft cell tower on his property. The application has already been submitted to the El Dorado County planning department for a special use permit to allow for industrial use in our residentially zoned neighborhood. Our family together with several other families living within just a few feet of this proposed industrial site strongly oppose the facility and tower being constructed due to it's highly intrusive nature.

The Telecommunications Act of 1996, one of the most lobbied bills in history, prevents local government from citing heath risks as a reason to deny a cell tower application, effectively silencing the American people. So despite numerous studies from reputable sources including The American Cancer Society and The World Health Organization that label cellular radiation as carcinogenic and that show cell towers increase the risk of cancer and other health issues, I won't waste any time on that subject. We do have several other concerns listed in the posts following this one along with evidence to support our concerns.

We are not opposed to cell towers. Cell towers are a necessary part of communication. They just need to be in locations where families lives are not being destroyed by their presence. Where the safety of our children is not being put in jeopardy. Where our home values are not being destroyed along with our financial futures. They need to be in safe locations where they will not destroy wildlife habitats, historical sites and ecological preserves. They need to be in a location where they will not cause the death of endangered animals. There has to be an alternative to the destruction of our community. The cost to our families, our farms and our community is too high at this site.

We are confident that with enough support from our community we can stop this tragedy from happening. Our families are asking you to please help by sending an email to the El Dorado County Planning Department at: planning@edcgov.us and ask them to deny the Victory Mine cell tower application for the project known as Tiger Lily Tower, file #S17-0007.
