Supervisors Frentzen and Novasel:

I understand there is to be a vote regarding a temporary moratorium on the issuance of new VHR permits. I am a homeowner and full-time resident in the Meadow Heights subdivision in the county area of South Lake Tahoe. I'm unable to attend the January 9 meeting, otherwise I'd be there to express my concerns in person. I strongly support any proposal that would halt further VHR permit approvals in our area. I know you've heard all the issues before: noise, traffic, overcrowding, safety, obnoxious/drunken behavior, commercial enterprises in R1 zones destroying quality of life, etc., so I'll spare you further details here. Suffice it to say I'd like my name added to the growing number of those who want to see this practice halted, and eventually, come to an end. I also believe if a hearing were held in South Tahoe, there would be a large turnout of folks who share my concerns, and much more. I don't think it can be overstated how much opposition there is here to VHR's.

I encourage all due urgency, as behemoth homes (motels) are being built all over town, and particularly because two huge spec homes are currently under construction in my immediate area. They are more than twice the square footage of most, and tower over all, of the homes in the surrounding neighborhood. They are ridiculously, if not obscenely, out of place, and will no doubt be marketed as potential vacation rentals.

Please share this with the rest of the Board, and if at all possible, have it read for members of the public in attendance.
