Comments on item #3-Rubicon Trail 2017 Annual Report

Let me preface these comments by saying that my normal means of enjoying wilderness type trails is self propelled—either on foot or by mt. bike, so I am a bit shocked reading the amount of time and money spent on maintaining the Rubicon Trail as reported in 18-0125 B Page 1 of 2 the this Annual Report.

A quick addition of some of the budgeted items, since there were no comprehensive totals provided in the report, comes to several hundred thousand dollars; including 2 deputies that patrol the trail in their state of the art Jeep, helicopter services to assist with rock and debris transport, septic servicing, close to \$80,000 for calendars and bandanas (!), and only around \$12000 for: "two full time employees who (sic) focus is to educate the public on proper use, to provide information on trail conditions, to assist with broken down vehicles, assist the Sheriff's as needed and to be the ambassadors of the trail."

Also of interest is the fact that these resources were allocated to support a visitor total of 2156 vehicles with 5005 total users for the season. These users generated a total of 320 lbs. of contaminated soil and 99 lbs. of oily debris. There were 102 "warnings" given to these individual or groups, with 4 cite/arrests.

In contrast to the above time and money, the River Management Program for El Dorado County receives no general fund support or money, no matching grant funds, and is almost entirely self funded by a \$2 user fee from Outfitters who use the river as a business venue. There were approximately 105,641 people who used the South Fork American River this summer during the managed season. There were 2 full time staff to manage the river and the river program. The money spent on managing the river for the entire 2016-17 year for this program was \$159,981.

There appears to be an incredible disparity between priorities for Parks and Recreation and the monies spent for both of these programs seem unjustifiably disproportionate to use.

Like I said in my preface, I know nothing about the Rubicon program except from what I have learned in the report, but I do know quite a bit about the River Management Program and find it disheartening to learn how much money has been spent, and continues to be budgeted, for a resource that benefits so few individuals.

The resource is indeed a gem, but to allot so much money and effort to a venue that very few residents and visitors will ever have the opportunity to use or even see seems unfair at best, and a tremendous waste of valuable money at worst.
