Mr. Throne was the founder and CEO in 2006 of Cirgon, a company that developed a media server for home entertainment.

He was co-owner of a consulting firm Emergency Planning Services from 2000-2003 and managed the development of the emergency plan for the Anchorage School District in Anchorage, AK. ASD was the third largest employer in Alaska.

In 1997, he was a founder, Vice President of Operations and CFO of Aptia, Inc., a network services company funded by Sutter Hill Ventures. .

Mr. Throne also founded Qlon, a developer of network products for industrial control applications. Customers were companies such as Lam Research and Applied Materials.

He worked in the early 90s as an independent consultant with DQ Alliances, an affiliate of Dataquest\Nielsen, performing strategic alliance work with a number of high technology companies in the Silicon Valley and Japan. This work was to get investment for Silicon Valley software companies from some of the largest companies in Japan such as Itochu, one of the largest trading companies in Japan.

He was founder, president and chief executive officer of Handar, a manufacturer of wide area environmental data acquisition systems that was sold to TSI Inc. of St Paul, MN in 1986.

Mr. Throne joined Hewlett Packard in 1966 where he developed several atomic frequency standards and managed the development of state of the art frequency counters. He is co-inventor of an innovative technology for microwave counters.

He served on the board of directors of Scientific Engineering from the late 90s to 2003. Scientific Engineering, a Reno, NV high tech company, produced acoustic pryrometers for electrical utility boilers that were sold worldwide.

Mr. Throne is currently retired, and lives in El Dorado Hills, CA with Sandy, his wife of 30 years.

Darwin co-authored the book *Managing High Tech Startups* and taught a class on business planning at Santa Clara University in the School of Engineering Management from 1992-1994. He also lectured at the University of Nevada, Reno to engineering classes on Sales and Marketing for high technology companies.
