I live in the vicinity of Villa Florentina. My property is affected by the announcements and loud music present every time Villa Florentina has an event. I have read the letters to the planning commission complaining that vendors will lose business without these events. Why should our neighborhood have to suffer with all the noise for the benefit of these vendors? We have lived here for 19 years, and the change in the neighborhood due to these events has been big and negative. The impact on the neighborhood should be the biggest factor considered, especially in a residential neighborhood. #### Dear Com missioners,

I am a property owner about ¼ mile from the venue, and live at a separate location from my daughter, who has also submitted information regarding this business. I can attest to the excessive noise coming from Villa Florentina over the last two years, and that it has continued since the last hearing. The unique aspects of sound traveling through this river channel should be considered here, and how it impacts many neighbors. Someone else ¼ mile away from the venue might not hear anywhere near as much noise, but that is not the case at my property, where the impact is significant.

Notwithstanding the emotional and often blatantly commercial exhibits being submitted in support of Villa Florentina, THIS IS A "RULE OF LAW" ISSUE. A special use permit (often called a conditional use permit) was issued by the Planning Commission, clearly stating the conditions which should be met for the operation of a commercial operation in a rural residential area. These rules should not depend on how "lovely" a venue is, and exist to defend the interest of other citizens. Residents, at the original hearing years back clearly stated that a bed and breakfast would be fine, but objected to the events center. The permit holder has clearly been shown to violate the permit as it pertains to events, using measurable data, and has not been able to refute the data. The modified permit as proposed would still allow for bed and breakfast operation.

Can conditions be met at this property? Perhaps so, but so far, in spite of repeated admonitions from the Planning Commission, this owner has failed to meet those conditions. Should he be given yet another chance? Remember that insanity is when you keep trying something over and over expecting different results. The owner has failed to meet the requirements and this should be a clear cut case. The owner himself stated, when asked by the commission at the last hearing, that he is not able to operate within the sound requirements when asked by the commission.

Please consider the rights and interests of the closest neighbors in deciding this issue. Their interests should not be ignored in the name of commerce, and their protections should be upheld.



I am a resident living on Carvers Rd near Villa Florentina and have been adversely affected by the noise of their large events and the traffic. I have previously submitted a letter and have spoken at an earlier hearing. Please adopt the recommendation of the Planning Department to modify their Special Use Permit to remove the use of special events and amplified music. The Bed and Breakfast business the Anderson's operate fits with the neighborhood and does not cause disturbances for their neighbors. The large events have repeatedly been a problem for myself and others in the neighborhood.

This is not about one "disgruntled" neighbor. This is about a WHOLE neighborhood. It is very easy for people to look from the outside in and say get over it or that it is a "slight inconvenience". It is a big inconvenience, a nuisance and a safety

To get to Villa Florentina you have to cross a one lane bridge and go down a one lane road. Villa Florentina is at the end of Carvers Road and on the narrowest part. There have been multiple occasions where the road has been blocked by cars waiting to get onto the property. Villa Florentina is not providing any traffic control which from my understanding is part of their Special Use Permit. When cars come and go they are at times driving at high speeds. Carvers Road has blind spots with one of them very close to the Villa. Since the Anderson's purchased Villa Florentina I have come close to multiple accidents there between myself and the Villa's guests, staff and vendors.


I have read many of the submitted comments from multiple people supporting Villa Florentina. But these people do not live in this neighborhood. One in particular comments that you cannot hear the music unless you are on the property. My brother lives a mile away and he can hear the music. Before I moved here I camped and stayed at numerous places in the community with friends. None of the many venues close to those areas music was at the level of the music held at Villa Florentina. There is repeated documentation of the noise levels at Villa Florentina being above the permitted levels. This is still happening even after the Anderson's were advised by your Committee to modify how they amplify their music during their events.

Businesses like Villa Florentina are important to our area and the County. But they are not the only venue for weddings and events in the area. There are 2 wineries in very close vicinity that offer wedding and event facilities that are beautiful and memorable and bring business to vendors in the area. I have attended multiple weddings and events at these places and have always been stunned at the beauty they offer.

I am asking as an individual and as a resident of this neighborhood that you please take all this into consideration when making your decision on the Special Use Permit. Thank you for your time and in advance for helping restore a sense of peace to our neighborhood.

Re: Special Use Permit S10-0009/Villa Florentina Bed & Breakfast

To the Planning Commission, El Dorado County:

Coming up is the third hearing about how the owners of Villa Florentina, Angela and Adam Anderson, do not follow the conditions of their Special Use Permit. This is the third time I have sent comments to you about how the noise from their events has interfered with my peaceful use of my residence, and my ability to have guests over to also enjoy the peace of the Rural Residential neighborhood where we are located. I entreat you to adopt the recommendation of the Planning Department to modify Special Use Permit S10-0009 to exclude special events and outdoor amplified music at Villa Florentina. It is simply the wrong place for large, loud events.

When I last spoke to the Planning Commission in August, I explained that I didn't know about decibels and sound tests but I did know when it is so loud from events at Villa Florentina that I cannot enjoy my house in peace. The first season they operated, I could hear every word of every vow in my back yard where I was trying to get work done. It was cute the first couple of times but the charm quickly wore out. I do not want to have weddings in my back yard, which is exactly how it sounds. You have heard me talk in the last two hearings about the music and yelling from the weddings that is very disruptive to me and to my neighbors.

There were two events since our last hearing in August 2017 that were so loud that I did in fact measure the sound. The county maximum level is 50 Db from 7-10pm and on October 14, 2017, my measured peak was 63.9 dB INSIDE my house with the max at 57.7 at 7:55pm. The allowable eq, or average ongoing noise, is 40 but I recorded 47.8 that night.

On October 7, 2017, I recorded a peak of 53.6 inside my house and an eq of 47.1 at 8:52pm. This high sound level disturbs not just me but also my family and friends I want to be able to have visit. I had a friend come up for an afternoon in September 2017. He left in daylight hours saying, "I heard about it, but I can't believe how loud the noise is here, it sounds like it's right over the fence. It totally defeats the point of living here, to have a loud party going on so close."

Some of the comments that have been submitted in this matter support Villa Florentina because it is a small business. I too support small businesses in Coloma-Lotus, which is why I favored giving events there a try back in 2012. However, we have learned painfully that Villa Florentina is too close to other houses, and the acoustics carry too much in our river valley, for large events to be hosted there without disturbing the neighbors, sometimes extremely. The recommended modification allows the Andersons to continue to operate a bed and breakfast, a small business that does fit in with the neighborhood.

Some people have said in their comments around this issue that when they are in their own homes, they enjoy the sounds they hear of people recreating. I am glad they enjoy their own sound levels. Except for the Villa Florentina events, I too enjoy the sounds of kids on field trips in Coloma, families enjoying picnics at the State Park across the river from me, people whooping it up on the river and enjoying nature, and the distant sounds of music from Coloma-Lotus

establishments in the summertime. I think it is healing for people to come here, to connect with nature and history, to have outdoor adventures here, and to enjoy tunes in our eateries. However, none of that is right in my back yard. Villa Florentina's events are too close to its neighbors to allow them to continue.


Another line of support is that Villa Florentina contributes to the local economy. Even if this is true – and I have seen no figures, and the only fact I have seen is that Placerville Flowershop, a great local business, gets about five orders of flowers per year from Villa Florentina events – this cannot come at the expense of the well-being of their surrounding neighbors.

The location of Villa Florentina is wrong for large events. It has been tried, the Planning Commission and Planning Department tried to work with the owners to make it work, but it is a failed experiment. However, it is a nice B&B. I ask that you modify this Special Use Permit to be for a bed and breakfast only, so the residents can again enjoy peace in our neighborhood.

Thank you for all your hard work for our County.



To the El Dorado County Planning Commission,

I am writing to provide an update regarding events held at Villa Florentina since the most recent Planning Commission hearing on 8/24/18. A majority of events held since that date have continued to significantly exceed decibel limits. All events held since 8/24/18 have violated the mandates set at that time by the Commission that were agreed to by the owners. Violations since 8/24/17 have included (see attached logs for details):

- Average and maximum decibel exceedences during portions of most events
- Use of lawn for ceremonies and reception games/traffic that was specifically prohibited by the Commission
- Amplification of sound outside permitted areas, including lawn
- Live brass (prohibited per sound study recommendations, absorbed in SUP section 3: Outdoor Music)

As I have stated since my first contacts with the property owners, Planning Department, and Planning Commission, my goal was for the business to operate in accordance with its SUP. My intent was *not* to end events. I am not a foe of small business or community commerce, and have only sought to protect my interests and those of neighbors living in the immediate vicinity. Sadly, this business has continued to operate in violation of SUP conditions, despite multiple requests from neighbors, and multiple directives and mandates from the Planning Department and Commission. Due to chronic violations of the SUP, and despite being given multiple opportunities to reach compliance, no alternative remains but to modify the SUP to remove such events and amplified music from the business's operation. Our community is governed by the rule of law, and law should be enforced to protect our interests in this case. There continues to be no neighborhood objection to the business operating as an area bed and breakfast.

In total, since the new owner began operation, 33 of 36 monitored events have violated decibel limits and amplified sound rules in the SUP and all 36 have used the unpermitted lawn expansion in violation of original proposed use. The upcoming modification hearing scheduled for 2/8/2018 is the third hearing date about this business. The neighbors have had to defend our interests repeatedly which has taken time away from work and family and has induced stress and uncertainty for all of us. Ongoing noncompliance has produced interference with our enjoyment of our lovely country neighborhood, and we're tired of it. One property owner's business interests should not supersede the rights of everyone else in the neighborhood, particularly one zoned as Rural Residential.

I have reflected on how much time and effort have gone into this business, and think listing it is helpful for recently interested community members to see how long and extensive this process has been. Planning Department and Commission efforts made to date to gain compliance from the current owner have included:

Letter #1 to Owner from Planning Department, dated 8/19/16

- Letter #2 to Owner from Planning Department, dated 10/12/16
- Letter to Owner from my attorney, dated 10/17/16
- Letter #3 to Owner from Planning Department, dated 11/4/16
- Planning Commission Hearing on 3/23/17 to consider if substantial evidence exists to justify a modification/revocation hearing
  - o Commission determined substantial evidence of noncompliance.
  - Multiple neighbors spoke and submitted letters outlining ongoing noncompliance and disruption.
  - Commission allowed hearing continuation to provide owners time and opportunity to conduct sound studies establishing compliant operating parameters.
  - Commission mandated that all events held after 3/23/17 comply with SUP, with restrictions on lawn use due to lack of permitting/ sound study of the expanded area.
- Planning Commission Hearing Continuation 8/24/17
  - Data due to the Planning Department on 7/3/17 from owner was not supplied prior to 8/24/17 hearing date, and was at that hearing found to be insufficient by the Planning Department.
  - Data submitted by owners confirmed decibel levels at events up to 20 Db above allowable maximums, with averages above limits as well.
  - When asked directly by the Commission, owner stated he could not operate events within county sound limits.
  - Multiple neighbors spoke and submitted letters outlining ongoing noncompliance and disruption.
  - Data I submitted confirmed continued violations of SUP during events held between 3/23/17 and 8/24/17.
  - o Commission stated parameters for operation until modification hearing:
    - All events held must comply with SUP.
    - Lawn area use not permitted for events, since sound study not conducted despite opportunity.
    - Planner Evan Mattes stated that evidence not provided by the owner in advance of the next hearing would not to be considered, due to his failure to provide timely documentation at this hearing.

A letter campaign has recently been conducted by the owner, and the Commission is in receipt of a large volume of correspondence advocating for continued event operation. The commission may remember evidence addressing issues in these letters from the first two hearings. One letter purports that to be adversely affected by events, one would have to be *at* the property line. To be clear, I AM at the property line, as are several other neighbors. A resident living a short distance away noted no impact at her property. She is lucky. However, her experience does not invalidate those of many close neighbors; acoustics in the valley create large impacts for some, while not for others. This was discussed at length by neighbors and an acoustical engineer on the first hearing date. Despite some letters that talk about only "one" neighbor being affected, calls, emails, letters and testimonies from multiple neighbors have

been submitted on multiple occasions over the last two years. The representation of a hearing prompted by a single grumpy neighbor catching a few infractions is inaccurate. One email complimented the business for limiting the number of events per year to 20 to accommodate the neighbors. This is a condition of the permit. In fact, in January 2017, the current owners petitioned to actually increase the number of events and operate year-round. The limited number of events has never been a gesture of goodwill by an owner being considerate to the neighborhood as it has been framed.

Some letters praise the venue's quality, generation of commerce, and ability to create positive experiences for guests. I do not dispute the beauty of the venue or experiences of guests participating in events there. We live in a beautiful neighborhood. However, no volume of letters invalidates the experiences of immediate neighbors, or the adverse impact on us each weekend in our homes during almost half the year. The charm of the venue is not the issue here; its misuse in violation of the SUP is the only issue that should be considered at this hearing.

I hope this is the last letter I will have to submit to the Planning Commission. Residents of the Coloma Valley enjoy the community here, the beauty of the outdoors, and the tranquility of this area, and we in this secluded neighborhood cherish our little corner of the valley. Please ensure that our legal rights are protected so we may continue to do so.

Regarding the data logs on the following pages:

As was shown in evidence submitted for the 3/23/17, my Sound Logger, which was used to take the data on the following pages, registers sound at 5-10 decibels less than the equipment used by Bollard Acoustical. As such, graphs underestimate the sound levels for events.

#### 8/26/17 Log

Amplification from lawn (testing) at about 3:30. Traffic on lawn starting at this time, for about 20 minutes. Ceremony setting up on lawn. 4:25 folks back on lawn. Ceremony quiet on lawn. 

#### Notes:

Each of the noise levels specified above shall be lowered by five dB for simple tone noises, noises consisting primarily of speech or music, or for recurring impulsive noises. These noise level standards do not apply to residential units established in conjunction with industrial or commercial uses (e.g., caretaker dwellings).

The County can impose noise level standards which are up to 5 dB less than those specified above based upon determination of existing low ambient noise levels in the vicinity of the project site.

In Community areas the exterior noise level standard shall be applied to the property line of the receiving property. In Rural Areas the exterior noise level standard shall be applied at a point 100' away from the residence. The above standards shall be measured only on property containing a noise sensitive land use as defined in Objective 6.5.1. This measurement standard may be amended to provide for measurement at the boundary of a recorded noise easement between all effected property owners and approved by the County.

\*Note: For the purposes of the Noise Element, transportation noise sources are defined as traffic on public roadways, railroad line operations and aircraft in flight. Control of noise from these sources is preempted by Federal and State regulations. Control of noise from facilities of regulated public facilities is preempted by California Public Utilities Commission (CPUC) regulations. All other noise sources are subject to local regulations. Non-transportation noise sources may include industrial operations, outdoor recreation facilities, HVAC units, schools, hospitals, commercial land uses, other outdoor land use, etc.

# Policy 6.5.1.11 The standards outlined in Tables 6-3, 6-4, and 6-5 shall not apply to those activities associated with actual construction of a project as long as such construction occurs between the hours of 7 a.m. and 7 p.m., Monday through Friday, and 8 a.m. and 5 p.m. on weekends, and on federally-recognized holidays. Further, the standards outlined in Tables 6-3, 6-4, and 6-5 shall not apply to public projects to alleviate traffic congestion and safety hazards.

additional noise level reduction from ground absorption and intervening topography would be expected to reduce guest noise levels to less than 40 dB  $L_{\rm eq}$  at the closest residential property line. Therefore, average guest noise levels would be expected to satisfy the applicable daytime and evening noise exposure limits at the closest residential property line.

Worst-case, maximum noise exposure from guest laughter, cheering, etc. would be expected to exceed the County's evening noise exposure limit of 50 dB ( $L_{max}$ ) at the closest residential property line to the north.

#### MITIGATION

#### Sound System



As presented above, noise exposure from a DJ sound system positioned in the covered patio area on the west side of the project residence would not be expected to exceed the applicable daytime or evening noise exposure limits at the closest residential property lines. It is critical that the sound system is placed in the covered patio area to take advantage of the acoustical shielding provided by the project buildings. The DJ sound system should not be positioned anywhere other than the covered patio area shown in Appendix A.

#### **Guest Noise**

Guest noise exposure during dinner or other times when the music is not a dominant noise source would not be expected to exceed the applicable 45 dB  $L_{eq}$  and 40 dB  $L_{eq}$  daytime and nighttime noise exposure limits, respectively, at the closest residential properties. To help mitigate the possibility of nighttime noise exposure impacts at neighboring residents, we recommend that reception activities end no later than 9:30 p.m. This would allow guests time to exit the project area before 10 p.m., limiting nighttime noise exposure in the project neighborhood.


#### CONCLUSIONS

Noise exposure from DJ Music and guests would not be expected to exceed the applicable daytime and evening average noise exposure criteria ( $L_{eq}$ ) at the closest residential properties. Maximum noise exposure ( $L_{max}$ ) from guest cheering, laughing, etc. would be expected to exceed the County's evening noise exposure criterion at the closest residential property to the north. There is no known mitigation for this impact.


Project-related noise exposure at neighboring residential uses may be reduced by limiting music to DJ sound systems or live, acoustic music (no amplification) with string and/or woodwind instruments only (no drums or brass). All music equipment or musicians should be positioning in the covered patio area as shown in Appendix A. Receptions should end no later than 9:30 p.m.




To the Planning Commission,
