To the attention of Planning and the Board of Supervisors.

At the last meeting three of the members of the panel seemed less than interested in the concerns brought to their attention regarding this project. As if they could have cared less about these heart felt health concerns and had nothing to add or to offer, questions or comments. Totally disinterested, sad!

Seems their minds were made up and the meeting was just a formal process that needed to happen.

Three or four other sites, that day, were approved with no comments or rebuttal. Couldn't other sites be found for the Tiger Lily project, with the same outcome? Those other sites will just go in as planned.

So with so many people on Victory Mine Road, especially those who are directly adjoining the parcel where the proposed tower is planned, how can this just be forced onto them?

Does the county have any financial gain for these new cell tower sites?

I would suggest each of those involved in the decision to approve or deny this project, to drive the road up to the proposed site. Please keep in mind that the easement they intend to use to get to the site is under litigation.
