AGREEMENT FOR SERVICES #055-S0911 AMENDMENT I

This Amendment I to that Agreement for Services #055-S0911, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and South Lake Tahoe Family Resource Center, a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 3501 Spruce Avenue, Suite B, South Lake Tahoe, CA 96150, (hereinafter referred to as "Contractor");

WITNESSETH

WHEREAS, Contractor has been engaged by County to provide support for a Latino Engagement Initiative in South Lake Tahoe for clients of the Mental Health Division of the Department of Health Services, in accordance with Agreement for Services #055-S0911, dated August 26, 2008, incorporated herein and made by reference a part hereof, and

WHEREAS, the Department of Mental Health has been reorganized and is now known as the Mental Health Division of the Health Services Department; and

WHEREAS, the parties hereto have mutually agreed to modify the term of said Agreement, hereby amending ARTICLE II, Term; and

WHEREAS, the parties hereto have mutually agreed to amend ARTICLE III - Compensation for Services; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #055-S0911 shall be amended a first time as follows:

All references in the original agreement to the "County Mental Health Department" or "MHD" shall be deemed to refer to the Mental Health Division of the Health Services Department.

ARTICLE II

Term: This Agreement as amended shall cover the period of July 1, 2008 through June 30, 2009.

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Contractor monthly in arrears. For the purposes hereof, the monthly billing rate shall be \$8,985.50.

Contractor shall submit monthly invoices for services no later than thirty (30) days following the end of a "service month." For billing purposes, a "service month" shall be defined as a calendar month during which Contractor provides services in accordance with ARTICLE I, "Scope of Services". Failure to submit invoices within 30 days following the end of a service month may result in a significant delay in payment. Payment shall be made within forty five (45) days following County's receipt and authorization of invoice(s). Invoices are to be sent accordingly:

The total amount of this Agreement shall not exceed \$107,826.00.

Except as herein amended, all other parts and sections of that Agreement #055-S0911 shall remain unchanged and in full force and effect.
