### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

### SIERRA DISPOSAL SERVICES SCHEDULE OF RATES

WHEREAS, a public hearing was held on December 9, 2008 for the purpose of implementing a 2.57% solid waste collection rate increase and a 9.66% service level rate increase within franchise area No. 7.

NOW, THEREFORE, be it resolved that effective January 1, 2009, the following rates are adjusted for the collection of solid waste within the Sierra Disposal Services franchise area:
