#### What are your organization's mission, goals and services?

It is the mission of the El Dorado County Senior Day Care Services program to provide adult day services that enable impaired adults to function at their maximum level of independence in an atmosphere that provides them the respect and care they deserve, while emphasizing a positive self-image and a belief in the possibility of improvement through continued stimulation of body, mind and spirit. In addition, it is our mission to be a support to families throughout their caregiving journey.

It is our goal to prevent premature institutionalization of older adults and to reduce the burden felt by caregivers through our services which include: a comprehensive assessment, care plan development and management, on-going assessments, specialized dementia care, assistance with medication and personal care, transportation, and group and individual exercises/activities designed to add meaning to our participants' lives, improve mental and physical functioning, and to increase their sense of worth. Individual counseling is provided to our caregivers in addition to multiple monthly support groups and educational workshops.

#### Describe briefly how funds are to be used:

Funds will be used to provide free day care services to family caregivers who do not have and/or cannot afford to pay someone to provide care and supervision of their loved one while they attend one of the support groups or educational workshops offered each month throughout the County by various groups including the Family Caregiver Support Program, Elder Options, and Senior Day Care Services.

# How will healthcare and our community benefit from this program? Approximately how many people will be served?

A large and growing body of evidence reveals that the stress of providing care for a chronically ill person can have harmful physical, mental, and emotional consequences for the caregiver. As families struggle to care for others, their own health is put in danger. However, research also demonstrates its effects can be alleviated at least partially by caregiver education and support programs and with respite to reduce caregiver burden. With funds from Marshall Foundation for Community Health, we will be able to provide 120 hours of respite care allowing 60 EDC caregivers the opportunity to break out of their isolation, get helpful advice and better preserve their own mental health by taking part in support groups and educational workshops.
