DEPARTMENT SUMMARY AND REQUESTED BOARD ACTION:		
On November 4, 2016, a Sale of Tax Defaulted Property was conducted by the Treasurer-Tax Collector's office. Parties of interest, as defined by Revenue & Taxation (R&T) Code §4675, were notified that the property identified as APN <u>327-150-37-100</u> was sold for <u>\$179,941.16</u> more than the amount required to satisfy delinquent taxes & costs of the sale. Three claims have been filed for the excess proceeds due to the sale of the property. The Auditor-Controller's office has reviewed the claim(s) and supporting documents and is of the opinion that the excess proceeds should be distributed as follows. The Auditor-Controller recommends that the Board of Supervisors authorize the Auditor-Controller to notify the following claimants of the Board's action(s) and disburse excess proceeds as determined by the Board, and that the Board authorize County Counsel to file an interpleader action to have a court of law decide which of the two remaining claimants is legally entitled to \$122,850.03 of the excess proceeds.
