### WE SERVE SENIORS WHO LACK THE RESOURCES TO HIRE PRIVATE LEGAL ASSISTANCE FOR SITUATIONS SUCH AS.....

#### 1. Financial Abuse -

Geraldine is 86 years old and lives alone on a fixed SS income. She began receiving threatening phone calls from a collection firm demanding \$1200 for a credit card she had never owned. She had never received any statements, bills, or demand letters. Eventually the collection firm filed a law suit, and Geraldine came to SLS. We represented her and eventually got the fraudulent debt cleared from her record. We see many of these cases where innocent seniors lack the resources to defend themselves.

#### 2. Consumer Finance -

Wayne is 80 years old and lives alone. His house is his only asset. He applied for a home equity loan with a large corporation for \$40,000 to pay credit card debts. He never received the money. His house was being threatened and his credit ruined. The mortgage holder will not return his calls. He could find no attorney he could afford to help him fight such a big firm. He came to SLS. SLS is now co-counsel with a firm in San Diego that specializes in mortgage fraud, and together a suit has been filed.

#### 3. Public Benefits Assistance -

Sara is 78 years old and lives in a trailer in Pollock Pines. She has been on Medi-Cal/SSI/Medicare for many years. She was suddenly denied benefits because of an administrative accounting error that she could not rectify. SLS appealed the ruling and her benefits are now restored.

#### 4. Foreclosures –

Patricia is 66 years old and lives alone in Cameron Park. She refinanced her house and made all payments timely, having receipts for every payment. Wells Fargo foreclosed on the property, claiming no payments had been made, and would not accept her proof nor discuss it with her. SLS filed a law suit and settled the case in the client's favor.

#### 5. Fraud -

Lavonne is 79 years old and lives alone in Georgetown. Her house is her only asset. She was tricked into signing a grant deed, transferring her house to a stranger claiming to be a real estate investor, being told and thinking she was signing a right of first refusal document. SLS filed a law suit, settled, and the courts voided the deed.

#### 6. Evictions –

Robert is 89, a disabled veteran, and lives in a small apartment in So. Lake Tahoe on a fixed income. He has lived in the same apartment for 5 years and has never missed a payment. His income check was lost in the mail and had to be re-issued, resulting in his first late payment. His landlord served him with eviction papers, unwilling to discuss the problem with him. SLS investigated and then negotiated with the landlord to give him more time for payment.

#### 7. Restraining orders –


Bill is a 69 year old retired veteran suffering from hepatitis with only a few months to live. He lives on a fixed income in an apartment in Shingle Springs. A relative moved in as a caretaker, then moved her boyfriend in when he got out of jail. They took over the apartment, forced Bill to live in the back bedroom, and threatened to beat him if he told anyone. SLS worked to get restraining orders against them both and have them evicted. SLS also connected him with county and veterans services to assist him.

#### 8. Estate documents –

Rose is 82 and suffering from terminal rheumatoid arthritis. She owns her tiny home but has no other assets. She is housebound, in a wheelchair, and living on a fixed income. She called and asked SLS to review her trust before she died. SLS went to her home and advised her regarding some changes to her documents, prepared the changes, and returned with a notary to have the documents signed, then took the documents to the recorder clerk for filing.

#### 9. Assistance After Death of Spouse -

Eleanor is 91 and recently lost her husband of 70 years. She lives on a fixed SS income. They had no children nor any close relatives. Her husband was the sole manager of their finances and she had no financial experience nor any skills. Their home was in the husband's name alone, so SLS represented her in a court hearing to have the house transferred to her name. SLS sorted her papers and documents, making phone calls and sending out notices, preparing affidavits of death, getting her assistance from other county programs, and preparing her own will and trust and powers of attorney documents.




# 3. Elder Protection Unit Fighting for Victims of Elder Abuse





- Multidisciplinary and coordinated approach to identify, reduce, and prosecute the incidence of financial and physical abuse of seniors in our county.
