

## RESOLUTION NO. 084-2011

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, in accordance with Section 202 of the El Dorado County Compensation Administration Resolution #227-84 applicable to represented employees, and Section 501 of the El Dorado County Salary and Benefits Resolution #323-2001 applicable to unrepresented employees, the Board of Supervisors shall by Resolution specify the number and classification of all authorized positions for each department of the County; and

WHEREAS, Resolution #089-2010 established the authorize Personnel Allocation based on the Fiscal Year 2010-2011 adopted Budget and has been subsequently amended by action of the Board; and

WHEREAS, due to current fiscal conditions, the Board of Supervisors deems it necessary to amend the Personnel Allocation to reduce the number of positions to achieve greater savings; and

WHEREAS, the Chief Administrative Office has recommended the reduction in the University of California Cooperative Extension program of one (1) Sr. Office Assistant (filled), one (1) Fiscal Technician (filled), and one (1) Executive Secretary (filled); and

WHEREAS, the Board gives direction to the Director of Human Resources to notify the respective bargaining units and the employees of the proposed deletions, and compute the respective retention points for each employee; and

WHEREAS, The Board directs Human Resources to meet and confer in regard to the impact of the initial layoffs that will become effective upon appropriate notice, as required by the respective Memoranda of Understanding between the County of El Dorado and the affected labor Organizations; and

WHEREAS, the reduction in filled positions in the University of California Cooperative Extension program will be effective on Friday, July 15, 2011; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of El Dorado does hereby amend, modify and/or alter its Authorized Personnel Allocation Resolution #089-2010 as set forth below:
