## Discussion:

Staff has received a request on May 9, 2018, from the project applicant to continue the project off calendar (Attachment A). The applicant did provide notice to planning staff that they are intending to pursue approval of the project through the Permit Streamlining Act (PSA). Planning Staff has requested that the project applicant provide clarification of whether they intend to continue pursuing the PSA process during project continuance. As of May 9, 2018 the applicant has indicated that they do not intend to pursue the PSA process so that the project may be continued off calendar.

The Planning Commission has the option to take one of the following actions; to approve the request and continue the project off calendar, to reject the request and continue the project to a date certain or to reject the request and hear the project in its entirety. Should the Planning Commission hear the project in its entirety, they would have the normal array of action options available to them for conditional approval, denial or continuance.
