COUNTY OF EL DORADO FACILITY USE AGREEMENT #957-00810 (#1028) SHERIFF'S SEARCH AND RESCUE STATION AMENDMENT II

THIS AMENDMENT II to that Agreement 957-O0810, made and entered into by and between the COUNTY OF EL DORADO, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and the SOUTH TAHOE PUBLIC UTILITY DISTRICT, A California Public Agency formed in 1950 pursuant to the Public Utility District Act, whose principal place of business is 1275 Meadow Crest Drive, South Lake Tahoe CA 96150 (hereinafter referred to as "DISTRICT").

WITNESSETH

WHEREAS, the COUNTY entered into an Agreement with the DISTRICT for the use of certain real property for the purpose of operating a Sheriff's Search and Rescue Station in the Tahoe Paradise area, in accordance with Facility Use Agreement #957-O0810 dated July 29, 2008, and Amendment I dated June 4, 2013, both incorporated herein and made by reference a part thereof; and

WHEREAS, the County desires to continue utilizing those portions of the PROPERTY described in the original Facility Use Agreement for the purpose of continued operation of the Sheriff's Search and Rescue station in Tahoe Paradise, California; and

WHEREAS, the parties hereto mutually agree to extend the term of the agreement for five (5) additional years hereby amending Section 10.

NOW THEREFORE, the parties do hereby agree that Facility Use Agreement #957-O0810 shall be amended a second time as follows:

Paragraph 10 is here by replaced with the following:

10. The term of this Agreement, as amended, shall cover the period of July 1, 2008 through June 30, 2023, unless said term is extended, by mutual agreement in writing thirty (30) days prior to the expiration date.

Except as herein amended, all other parts and sections of said Facility Use Agreement #957-O0810 shall remain unchanged and in full force and effect.
