

RE: CAO Adopt Development Impact Mitigation Fees for El Dorado Hills Community Services

District

Dear Board of Supervisors,

My name is Sue Hawkes. As a resident of El Dorado Hills I am writing to tell you that I respectfully support the impact mitigation fee update being proposed by the Community Services District. Over the last ten years I have witnessed firsthand the CSD fulfilling its mission to "enhance the quality of life for El Dorado Hills residents through innovative, responsible leadership and by providing superior services and facilities." The CSD has been able to achieve this by securing necessary funding to meet the expectations of this community. One very important tool that has facilitated this accomplishment has been provided by the park impact fees – fees that are applied to new home permits to ensure that the effects of adding new population are appropriately offset. When impact fees are not adequately assessed I know, as a resident, that the burdens of new population will be placed on me and my neighbors. This will be evident in many ways, including a lack of enrollment spots in recreation programming - kids will not have the opportunity to play their favorite sport; parks that were expected to be built either will not materialise or will be delayed for a future generation - not the generation that was supposed to enjoy those awesome spaces and places; and, there will be a general decline in the high quality of parks and facilities that we have all come to expect and enjoy in El Dorado Hills and El Dorado County.

As Vice-President of El Dorado Dog Owners Guild lobbying for and providing leash-free dog parks in the County and more recently as Vice-President of the EDH Promise Foundation, a non profit organization that supports the community through philanthropy, I have had a closer than average relationship with the CSD and its outstanding Board members and staff than most residents. I have truly never lived in a community whose CSD so impressively puts the needs of its residents on such a high plateau and genuinely strives to enhance the quality of life for all.

You are probably aware of many of the parks and facilities that the CSD has developed with the aid of funding from impact fees:

Promontory Community Park Lake Forest Village Park Valley View Sports Park Laurel Oaks Park Kalithea Village Park Windsor Point Park Creekside Greens Park Murray Homestead Park

But did you also know that those impact fees also assisted in providing the following?:

At Community Park - Playground, Skateboard Park, Dog Park, Teen Center, Pool Renovations and Enhancements.

Park enhancements, including playgrounds, picnic areas, parking and tennis court or other courts at: Stephen Harris Parks; Parkview Heights; Bertelsen Park; Fairchild Park and Bocce Ball Courts at Promontory Park (opening soon)

And then there are the parks yet to be built – which we may not see realized in a timely manner if this fee update is not approved:

Carson Creek – Heritage Park Community Park at Bass Lake Mutigenerational Community Center Valley View Village Parks – Two Parks Community Park South of Highway 50 Aquatic Facility

I gather that there is an argument being made that this impact fee update will hurt the County's ability to meet the State's affordable housing goals. The fact is, that affordable housing comes from denser zoning projects (i.e., more homes per acre and multi-family dwelling). It appears as though the fee update that the CSD is proposing is not only based on a sound analysis, but that they have removed the fee that would be applied to mobile homes, and have kept a lower multi-family dwelling unit value. Furthermore, the CSD has not asked to raise the fee in over 11 years – what strides have been made by the County to meet the affordable housing goals during those years of no park impact fee increases?

Please make the correct decision for the residents you serve who are living here in El Dorado Hills. Please make the correct decision that will ensure the residents of this community and County will continue to enjoy a first class and enviable park and recreation system and a wonderful place to live.


