The County of El Dorado Planning Commission will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on June 14, 2018, at 8:30 a.m., to consider the following: Conditional Use Permit S17-0019/AT&T CAF II Project (Auburn Lake Trails) submitted by AT&T MOBILITY C/O EPIC WIRELESS (Agent: Jared Kearsley) to allow the construction of a 160-foot high monopole wireless communication facility within a 40-foot x 45-foot enclosed area. The property, identified by Assessor's Parcel Number 071-400-30, consisting of 5.102 acres, is located on the north side of Cramer Court approximately 1,545 feet east of the intersection with Cramer Road, in the Cool area, Supervisorial District 4. (County Planner: Evan Mattes) (Mitigated Negative Declaration prepared)*

*This is a notice of intent to adopt the negative declaration or mitigated negative declaration that has been prepared for this project and which may be reviewed and/or obtained in the County of El Dorado Planning and Building Department, 2850 Fairlane Court, Placerville, CA 95667, during normal business hours or online at <http://edcapps.edcgov.us/Planning/ProjectInquiry.asp>. A negative declaration or mitigated negative declaration is a document filed to satisfy CEQA (California Environmental Quality Act).
