RECOMMENDATION: Commissioners will discuss and consider applications from Drew Woodall and Janet Saitman to serve a three-year term through June 30, 2021.

BACKGROUND:

Commission membership established in by-laws, Article VI, Section B, "Members of the Commission are appointed in accordance with the process established by the El Dorado County Board of Supervisors for County Commissions". On May 13, 2013, Commissioners voted to establish three-year terms adding Section D to the bylaws, "Members shall serve for terms of three years and until his/her successor is appointed by the Board of Supervisors. There is no limit to the number of terms an appointed Commission member may serve."

DISCUSSION:

Terms for Commissioners Woodall and Saitman, Community Representatives, will expire on May 31, 2018. Vacancies for two positions were posted from March 26 – April 9, 2018. Both Commissioners have submitted applications within the vacancy period for a three-year term, through May 31, 2021 (Attachments 1 & 2). No other applications were submitted.

CONCLUSION:

Commissioners applying for a subsequent, three-year term provides consistent leadership and history while the Commission facilitates its five-year strategic plan.
