WASTE CONNECTIONS OF CALIFORNIA, INC., dba<br>EL DORADO DISPOSAL SERVICE<br>Franchise Areas A, B, and C

WHEREAS, a public hearing was held on June 12, 2018 for the purpose of adjusting solid waste collection rates in the Waste Connections of California, Inc., dba, El Dorado Disposal Service, Franchise Areas A, B, and C; and

WHEREAS, County Ordinance section 8.42 .150 provides that the Board of Supervisors shall set the rates to be charged by a franchisee at such time as the Board deems appropriate; and

WHEREAS, pursuant to County Ordinance section 8.42 .170 and Government Code section 66016, the franchisee has provided written notice to each ratepayer of the proposed adjustment in a form approved by the County of the time, date, and place of the public hearing to set rates and the notice was provided at least ten but no more than sixty days before the public hearing; and

WHEREAS, pursuant to County Ordinance section 8.42.170 and Government Code section 66016, notice of the time, place, and purpose of the public hearing has been published in a newspaper of general circulation printed and published in the County, one each week, for two consecutive weeks prior to such hearing.

NOW, THEREFORE, be it resolved that for the 2018 base year, effective July 1, 2018, the following rates are adjusted upward by five and two-hundredths percent $(5.02 \%)$ for the collection of solid waste within the El Dorado Disposal Service Franchise Areas A, B, and C.
