## AGREEMENT FOR SERVICES #117-S0811 AMENDMENT II

This Amendment II to that Agreement for Services #117-S0811 made and entered by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Tri-Signal Integration, Inc., a California Corporation duly qualified to conduct business in the State of California, whose principal place of business is 12701 Encinitas Avenue, Sylmar, CA 91342, with their local place of business at 1430 Greg Street, Suite 501, Sparks, NV 89431 (hereinafter referred to as "Contractor");

#### WITNESSETH

WHEREAS, County has determined that it is necessary to obtain a Contractor to provide annual testing, inspections, monthly preventive maintenance and repairs "as needed" on the Fire Alarm Systems and the CCTV Camera, Intercom and Electronic Door Controls at the South Lake Tahoe Jail and the South Lake Tahoe Juvenile Treatment Center in accordance with Agreement for Services #117-S0811, dated November 1, 2006, and Amendment I dated December 9, 2008, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to amend the Scope of Service and increase the billable hourly service rate of said Agreement, hereby amending ARTICLE I – Scope of Services, and ARTICLE III-Compensation for Services, and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #117-S0811 shall be amended a second time as follows:

#### ARTICLE I shall be amended in its entirety as follows:

Scope of Services: Contractor agrees to furnish personnel, equipment and parts to provide annual testing, inspections, monthly preventive maintenance and repairs or any other additional required improvements/additions "as needed" on the Fire Alarm Systems and the CCTV Camera, Intercom and Electronic Door Control System at the South Lake Tahoe Jail and the South Lake Tahoe Juvenile Treatment Center. Services shall be in accordance with AMENDED - Exhibit "A", marked "Scope of Services", incorporated herein and made by reference a part hereof.

### ARTICLE III shall be amended in its entirety as follows:

Compensation for Services: For services provided herein, County agrees to pay Contractor upon completion of annual testing of the fire alarm systems located at both the South Lake Tahoe Juvenile Treatment Center and the South Lake Tahoe Jail; and monthly in arrears for testing, inspection, preventive maintenance and repairs "as needed" on the CCTV Camera, intercom and electronic door control system located at the South Lake Tahoe Treatment Center and the South Lake Tahoe Jail. Payments shall be made within thirty (30) days following County's receipt and approval of invoice(s) identifying services rendered. For the purposes of this Agreement, the billing rates shall be in accordance with AMENDED - Exhibit "A".

When applicable, County requires Contractor's services on public works project(s) involving local, state and/or federal funds to which prevailing wage requirements may apply to pay and require payment of wages according to a scale of prevailing wage rates determined by California law. As a consequence, Contractor shall comply with all applicable state and federal prevailing wage rates, statutes, rules and regulations, if applicable, and in accordance with wage requirements as set forth in Labor Code Section 1770 et. seq., 1773.2, 1775.1776, 1810 and 1813.

As required under the provisions of Labor Code Section 1776, Contactor and subcontractors shall keep accurate payroll records. A certified copy of all payroll records shall be available for inspection at all reasonable hours at the local branch office of the Contractor.

The total amount of this Agreement shall not exceed \$94,404.00, inclusive of all parts and materials.

Except as herein amended, all other parts and sections of the Agreement #117-S0811 shall remain unchanged and in full force and effect.
