## AMENDMENT I TO AGREEMENT FOR LEGAL SERVICES BETWEEN EL DORADO COUNTY AND DOWNEY BRAND, LLP

This Amendment I to that Agreement for Legal Services dated June 26, 2007, is made and entered into between EL DORADO COUNTY ("County"), a political subdivision of the State of California, and DOWNEY BRAND, LLP ("Attorney"), duly authorized to do business in the State of California, whose address is 621 Capitol Mall, Eighteenth Floor, Sacramento, California, 95814.

WHEREAS, Attorney has been engaged by County to advise, assist, and represent County in the claim and litigation from Yubacon, Inc., concerning the El Dorado Hills Boulevard Interchange project and all necessary or related court proceedings in mediation, arbitration, or superior court, in accordance with the Agreement for Legal Services dated June 26, 2007 ("Agreement"), incorporated herein and made by reference a part hereof;

WHEREAS, the parties hereto have mutually agreed to amend Section 4 of the Agreement addressing the parties respective responsibilities for advancing certain litigation expenses.

**NOW THEREFORE**, the parties do hereby agree that the second paragraph of Section 4 of the Agreement shall be amended as follows:

Mileage will be billed at the IRS reimbursable rate; however, Attorney shall not bill for travel time or mileage from its Stockton office to its Sacramento office and vice-versa. County shall reimburse Attorney for the reasonable costs of long distance telephone calls, mailing, photocopying, legal research on electronic databases, and, upon prior approval, for extraordinary photocopying and extraordinary facsimile transmissions. Other reasonable, customary and necessary expenses <u>in an individual amount less than or equal to \$500</u>, including but not limited to statutory fees, witness fees, reporters' per diem and transcription fees, jury fees, and expenses of serving process, shall be advanced by Attorney and reimbursed by County. <u>Any such expenses in an individual</u> <u>amount greater than \$500 may be invoiced to County as an "incurred but unpaid"</u> <u>expense and, upon receipt of payment from County, Attorney shall directly pay</u> <u>the subject expense</u>. Expert consultants and witnesses may be retained by Attorney with the County's prior approval. Except as herein amended, all other parts and sections of the Agreement shall remain unchanged and in full force and effect.
