Describe the agricultural activities in which you are currently involved.

I currently grow 24 acres of wine grapes (and planted 17 of the acres since 1996), including 14 varieties in seven estate vineyards. I am the owner and founding winemaker of Oakstone Winery, and owner and winemaker for Obscurity Cellars.

Describe your experience in the field of agriculture (please be specific).

I have grown wine grapes in New York and New Jersey beginning in 1974, and have been growing wine grapes in California since 1989. I was the winemaker at Single Leaf Winery from 1992 to 1996, and built Oakstone Winery in 1996 and Obscurity Cellars in 2004. I have entered into two Williamson Act Contracts, obtained two winery building permits, and one special use permit for a winery in this County.

Please give the reasons you wish to serve as a member of the El Dorado County Agricultural Commission.

As the Fair Play Winery Association representative, I have attended most of the Ag Commission meetings between 1998 and 2009. I have served on the industry and steering committees to assist in revising the County Winery ordinance, and have worked aggressively to ensure its passage. During this process, I have established an excellent rapport with the leadership of the Planning Services Department and with members of the Board of Supervisors. I have become familiar with the zoning ordinances and regulations that govern agriculture in El Dorado County and with the policies and practices of the Ag Commission, and I am experienced with the interpretation of legal issues and documents. I am firmly committed to the growth of agriculture in this County, and I will be diligent in working to create a climate in which agricultural pursuits are valued and encouraged by the community and its leaders.
