
## THE FOLLOWING CONDITIONS ARE REQUIRED FOR **ALL ROAD CLOSURES:**

- The organizers shall provide a detailed signing and detour plan for any proposed closure of a 1. major county road. This signing/detour plan should identify the type and location of all signs, barricades, cones, and flaggers. The plan must be attached to this application when it is submitted for review.
- The organizers shall provide proof that the owners of the adjacent business along the road closure are in agreement with proposed closure. These agreements must be attached to this application when it is submitted for review TO BUSINESSES IMPRETED BY CLOSURE 3.
- The organizers shall be responsible for providing all signs, barricades, cones, flaggers, and traffic 4.
- Wooden barricades shall be placed across the County road to close the road. Barricades shall also be placed across all intersecting roads to deny access to the closed road. 5.
- A "ROAD CLOSED" sign shall be placed at each barricaded intersection. Each sign shall measure at least 48 inches by 30 inches, with 8 inch black letters on a white background. 6.
- The organizers shall remove all signs, all pavement markings or other materials immediately following the event. The organizers shall also remove all debris deposited by participants and
- The organizers shall provide a Certificate of Insurance, naming El Dorado County Department of 7. Transportation additionally insured, in the amount of \$1,000,000.00 (one million dollars) as required by the El Dorado County Risk Manager. 8.
