Not withstanding any other terms and conditions contained herein, the following terms and conditions shall be incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to update the COMPENSATION clause of said Agreement; and

WHEREAS, the parties hereto have mutually agreed to update the ADMINISTRATOR clause of said Agreement; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #049-S0810 shall be amended a first time as follows:

COMPENSATION: The total amount of this Agreement shall not exceed \$9,000 per annum, inclusive of all expenses.

ADMINISTRATOR: The County Officer or employee with responsibility for administering this Agreement is Louise Gresham, Assistant Treasurer/Tax Collector, or successor.

Except as herein amended, all other parts and sections of that Agreement #049-S0810 shall remain unchanged and in full force and effect.
