**GENERAL PLAN AMENDMENT/REZONE**

**FILE NUMBER:** A08-0016/Z08-0040/El Dorado Mirage Plaza

**APPLICANT:** Carlton Engineering, Inc. (Jeff Thompson)

**PROPERTY OWNER:** El Mirage Group

**REQUEST:** The project consists of the following requests:

1. General Plan amendment amending the land use designation from Medium Density Residential (MDR) to Commercial (C).
2. Zone change from Single-Family Three-Acre Residential District (R3A) to Commercial-Planned Development (C-PD).

**LOCATION:** On the south side of Runnymede Drive, approximately 0.1 miles east of the intersection with El Dorado Road in the Placerville area, Supervisorial District III. (Exhibit A)

**APN:** 327-150-03 (Exhibit B)

**ACREAGE:** 10 acres

**GENERAL PLAN:** Medium Density Residential (MDR) (Exhibit C)

**ZONING:** Single-Family Three-Acre Residential District (R3A) (Exhibit D)

**ENVIRONMENTAL DOCUMENT:** Negative Declaration

**RECOMMENDATION:** Planning Services recommends the Planning Commission forward the following recommendation to the Board of Supervisors:

1. Adopt the Negative Declaration based on the Initial Study prepared by staff; and
2. Approve General Plan amendment application A08-0016 and Rezone application Z08-0040 based on the findings in Attachment 1.

### **STAFF ANALYSIS**

Staff has reviewed the project for compliance with the County's regulations and requirements. An analysis of the proposal and issues for Planning Commission consideration are provided in the following sections.

**Project Description:** General Plan amendment from Medium Density Residential (MDR) to Commercial (C) and a zone change from Single-Family Three-Acre Residential District (R3A) to Commercial-Planned Development (C-PD). No development is proposed at this time. Planning Services has proposed the addition of a Planned Development overlay, and the applicant has agreed to the addition, to ensure that project specific development impacts are reviewed in a subsequent discretionary planned development application. Proposed project access would be via Runnymede Drive. The project would be served by public sewer and water provided by the El Dorado Irrigation District.

**Site Description:** The project site is bound by U.S. Highway 50 to the north, single-family residences to the east, single-family residences and undeveloped land to the south, and a commercial business to the west. Elevation of the project site ranges from approximately 1,560 feet to 1,680 feet above sea level. Topography in the project study area ranges from gentle to steep slopes of varying aspect. Approximately 0.219 acres of wetlands and waters are located on the project site. Eight acres of the subject site is classified as mixed oak woodland. Existing improvements within the property consist of a single-family residence, outbuilding, driveway, and landscaping.

**Discussion:** The subject and adjacent parcels are within the Diamond Springs – El Dorado Community Region. A multi-family affordable housing project was previously approved on an adjoining parcel to the southwest of the subject site.

**Access/Road Improvements:** Proposed project access would be via Runnymede Drive. A second potential point of site access would be explored prior to development plan application submittal. Additionally, the Department of Transportation would recommend appropriate road improvement conditions of approval prior to development plan approval by the Planning Commission at a future date.

**Fire Protection:** Fire protection services would be provided to the project site by the Diamond Springs-El Dorado Fire Protection District as required under General Plan Policy 5.7.1.1. Based on comments by the Fire District, the Fire District is supportive of the project provided that specific fire safe issues are addressed at time of development plan review along with the inclusion of appropriate conditions of approval.

**Land Use Compatibility:** As previously discussed and shown in the “adjacent land uses table” above, the Commercial General Plan land use designation and zone district would be compatible with the existing and proposed surrounding commercial and multi-family residential land uses and would not create land use conflicts with surrounding properties. Future development of the site would require the submittal of a discretionary planned development application to ensure compatibility with surrounding land uses. As such, the project would be consistent with General Plan Policy 2.2.5.21.

**Water Supply and Fire Flow:** General Plan Policy 5.2.1.3 requires that commercial development projects be required to connect to a public water system when located within a Community Region. El Dorado Irrigation District would provide water to the project site. According to their letter dated January 30, 2009, the project would require approximately 89 EDUs (equivalent dwelling units) of water. At this time, there are approximately 2,426 EDUs available in the Western/Eastern Water Supply Region as of January 1, 2007. The system would connect to an existing 8-inch waterline located in Runnymede Drive near the project site which would provide the necessary fire flow.

**Wastewater Disposal:** General Plan Policy 5.3.1.1 requires commercial projects to connect to public wastewater facilities as a condition of approval. The EID has stated in their letter dated January 30, 2009 that there is an 8-inch sewer force main located in El Dorado Road. In order to receive service from this line, an extension of facilities of adequate size must be constructed, as well as a District owned sewer lift station. This sewer line has adequate capacity at this time.

**General Plan:**

The General Plan designates the subject site as Medium Density Residential. This land use designation establishes areas suitable for detached single-family residences with larger lot sizes which will enable limited agricultural land management activities. The maximum allowable density is one dwelling unit per acre.

The requested General Plan Amendment would change the land use designation to Commercial (C). The purpose of this land use category is to provide a full range of commercial, retail, office, and service uses to serve the residents, businesses, and visitors of El Dorado County. Mixed use development of commercial lands within Community Regions and Rural Centers shall be permitted provided the commercial activity is the primary and dominant use of the parcel. Except as provided in Policy 2.2.2.3, this designation is considered appropriate only within Community Regions and Rural Centers. The project parcel is located within the Diamond Springs – El Dorado Community Region.

The amendment from MDR to C would allow for a full range of commercial uses. It would also permit a mixed-use development with a maximum residential density of 10 dwelling units per acre. This would represent an increase from the current potential residential density under MDR for 20 dwelling units (one primary dwelling unit and one second dwelling unit per parcel) to a potential for 100 dwelling units. Within Community Regions, the mixed uses may occur vertically. As proposed, the Commercial General Plan land use designation and zone district would be compatible with the existing and proposed surrounding commercial and multi-family residential land uses and would not create land use conflicts with surrounding properties. The site adjoins commercially designated lands and multi-family designated lands and is located at the southeast corner of U.S. Highway 50 and El Dorado Road which is an area developing into a commercial center. The site is also in close proximity to the proposed El Dorado Crossing shopping center and other future commercial uses. Future development of the site would require the submittal of a discretionary planned development application to ensure compatibility with surrounding land uses. The site is suitable for commercial and mixed use development and the initial study did not find any significant impacts that could be associated with development of the site.

Additionally, the following General Plan policies also apply to this project:

**Policy 2.5.2.1** states that neighborhood commercial centers shall be oriented to serve the needs of the surrounding area, grouped as a clustered, contiguous center where possible, and should incorporate but not be limited to the following design concepts as further defined in the Zoning Ordinance.

- A. Maximum first floor building size should be sized to be suitable for the site;
- B. Residential use on second story;
- C. No outdoor sales or automotive repair facilities;
- D. Reduced setback with landscaping and walkways;
- E. Interior parking, or the use of parking structure;
- F. Bicycle access with safe and convenient bicycle storage area;
- G. On-street parking to reduce the amount of on-site parking;
- H. Community bulletin boards/computer kiosks;
- I. Outdoor artwork, statues, etc., in prominent places; and
- J. Pedestrian circulation to adjacent commercial centers.

Discussion: The addition of the planned development overlay would ensure that any future development plan is reviewed in light of the above criteria as well as any applicable design guidelines.

**Policy 2.2.5.3** directs that the County shall evaluate future rezoning: (1) To be based on the General Plan's general direction as to minimum parcel size or maximum allowable density; and (2) To assess whether changes in conditions that would support a higher density or intensity zoning district. The specific criteria to be considered include, but are not limited to, the following:

1. Availability of an adequate public water source or an approved Capital Improvement Project to increase service for existing land use demands;
2. Availability and capacity of public treated water system;
3. Availability and capacity of public waste water treatment system;

Discussion: General Plan Policies 5.1.2.1 and 5.1.2.2 require that prior to approval of any discretionary development a determination of the adequacy of the public services and utilities to be impacted shall be made, and the development shall not result in a reduction of services below minimum established standards.

The area is served by public water and sewer. A Facilities Improvement Letter from the El Dorado Irrigation District was submitted by the applicant. The letter states that existing nearby water facilities would provide necessary potable water and fire flow for the maximum density allowed on the project site. Additionally, sewer facilities are adjacent to the project site and contain capacity at this time.

4. Distance to and capacity of the serving elementary and high school;

Discussion: Under Policy 5.8.1.1, school districts affected by a proposed development shall be relied on to assess any impacts on school facilities. Schools in the area have experienced a decrease in enrollment and therefore there is existing capacity. Future commercial or mixed use development of the project area would not result in an increase in demand on existing services for the local elementary and high school district.

5. Response time from nearest fire station handling structure fires;

Discussion: A fire station staffed by the Diamond Springs - El Dorado Fire Protection District is approximately 1.5 miles from the subject parcel.

6. Distance to nearest Community Region or Rural Center;

Discussion: The project parcel is located within the Diamond Springs – El Dorado Community Region.

7. Erosion hazard;

Discussion: Under Policy 7.3.2.2, projects requiring a grading permit shall have an erosion control program approved, where necessary. No grading is proposed with the amendment and rezone application. Future development must adhere to the County's grading and erosion control requirements.

8. Septic and leach field capability;
9. Groundwater capability to support wells;

Discussion: The project parcels would be required to connect to existing public water and sewer. Public water and sewer capability is discussed under criteria 1-3 above.

10. Critical flora and fauna habitat areas;
11. Important timber production areas;
12. Important agricultural areas;
13. Important mineral resource areas;

Discussion: As discussed in the Initial Study, the project parcel is not in any designated areas for these criteria.

14. Capacity of the transportation system serving the area;

Discussion: The project parcel is accessed from Runnymede Drive, which is a County maintained road. The project is approximately 800 feet El Dorado Road/U.S. Highway 50 on-ramp. Approximately 528 feet from the project parcel, Runnymede Drive connects with El Dorado Road

which is also a county maintained road. General Plan policies, primarily those listed under Goal TC-X, require the developer and the County to review, and if necessary mitigate, the project's short term traffic impacts. As this is only an amendment and rezone at this point, with no development proposed, it is premature to attempt such an analysis. Impacts for residential use on the surrounding road system were analyzed in the 2004 General Plan Environmental Impact Report but future development may require additional traffic studies if projects exceed thresholds. Comments were received from the Department of Transportation detailing proposed conditions that would apply to future development. Therefore, the conversion to a commercial designation would be consistent with Goal TC-X as it represents an approximate 1.85 percent increase in the Commercially designated land area within Market Area #3 (Diamond Springs) as analyzed in the El Dorado County General Plan Environmental Impact Report (EIR).

15. Existing land use pattern;

Discussion: The project site is bound by U.S. Highway 50 to the north, single-family residences to the east, single-family residences and undeveloped land to the south, and a commercial business to the west. As proposed, the zone change would be compatible with the existing and proposed surrounding commercial and multi-family residential land uses and would not create land use conflicts with surrounding properties. As proposed, the Commercial General Plan land use designation and zone district would be compatible with the existing and proposed surrounding commercial and multi-family residential land uses and would not create land use conflicts with surrounding properties. The site adjoins commercially designated lands and multi-family designated lands and is located at the southeast corner of U.S. Highway 50 and El Dorado Road which is an area developing into a commercial center. Existing commercial land uses are located immediately to the west of the subject site as well as north of U.S. Highway 50. The amendment from medium density residential to commercial would be consistent with the land use pattern.

16. Proximity to perennial water course;

Discussion: Indian Creek is an intermittent stream located on the project site.

17. Important historical/archeological sites; and

Discussion: A cultural resources investigation of the project site did not identify any archaeological or historic features.

18. Seismic hazards and present of active faults.

Discussion: As shown in the Division of Mines and Geology's publication Fault Rupture Hazard Zones in California, there are no Alquist-Priolo Special Studies Zones mapped in El Dorado County. The impacts from fault ruptures, seismically induced ground shaking, or seismic ground failure, or liquefaction are considered to be less than significant. Any potential impact caused by locating buildings in the project area would be offset by the compliance with the Uniform Building Code earthquake standards.

19. Consistency with existing Conditions, Covenants, and Restrictions.

Discussion: The project parcel does not have any existing CC&Rs. CC&Rs may be required for future development.

**Policy 10.1.5.5** *directs that the County recognize and promote the need to create greater opportunities for El Dorado County residents to satisfy retail shopping demands in El Dorado County.*

Discussion: The General Plan Amendment to a Commercial land use designation and related zone change request would designate additional land at an appropriate location to accommodate needed retail and commercial development.

**Conclusion:** As discussed above, staff finds that the project, as proposed/conditioned, conforms to the General Plan.

**Zoning:**

The project includes a rezone request which would amend the zoning district from R3A to C - PD and is consistent with the request for a General Plan amendment from MDR to C. The subject parcel is consistent with the development standards for the proposed C zone district. Specifically Ordinance section 17.32.040 specifies a minimum parcel size of 5,000 square feet. The subject parcel is approximately 10 acres (435,600 square feet) which greatly exceeds the minimum.

**ENVIRONMENTAL REVIEW**

Staff has prepared an Initial Study (attached as Exhibit G) to determine if the project has a significant effect on the environment. Based on the Initial Study, staff has determined that there is no substantial evidence that the proposed project would have a significant effect on the environment and a Negative Declaration has been prepared.

**NOTE:** This project is located within or adjacent to an area which has wildlife resources (riparian lands, wetlands, watercourse, native plant life, rare plants, threatened and endangered plants or animals, etc.), and was referred to the California Department of Fish and Game. In accordance with State Legislation (California Fish and Game Code Section 711.4), the project is subject to a fee of \$1,993.00 after approval, but prior to the County filing the Notice of Determination on the project. This fee plus a \$50.<sup>00</sup> recording fee, is to be submitted to Planning Services and must be made payable to El Dorado County. The \$1,993.00 is forwarded to the State Department of Fish and Game and is used to help defray the cost of managing and protecting the States fish and wildlife resources. However, staff has determined that the project would have no impact on biological resources. Potential impacts to biological resources would be further evaluated at time of development plan application submittal. As such, the applicant may request a "No Effect Determination Form" from the California Department of Fish and Game to waive payment of said fee.



POR. HIGHWAY VIEW TERRACE SUBDIVISION






**General Plan Land Use Map**



Dear Mr. Shamma:

This letter is in response to your request dated November 17, 2008. This letter is valid for a period of two years. If a Facility Plan Report (FPR) for your project has not been submitted to the District within two years of the date of this letter, a new Facility Improvement Letter will be required.

Design drawings for your project must be in conformance with the District's *Water, Sewer, and Recycled Water Design and Construction Standards*.

This project is a mixed use (Multi-Family/Commercial) property rezone on 10.00 acres. Water service, sewer service, and fire hydrants are requested. The property is within the District boundary.

### **Water Supply**

This letter is not a commitment to serve, but does address the location and approximate capacity of existing facilities that may be available to serve your project. In terms of water supply, as of January 1, 2007, there were 2426 equivalent dwelling units (EDUs) available in the Western/ Eastern Water Supply Region. Your project, as proposed on this date, would require 89 EDUs of water supply.

### **Water Facilities**

The Diamond Springs/El Dorado Fire Protection District has determined that the minimum fire flow for this project is 1500 GPM for a two-hour duration while

maintaining a 20-psi residual pressure. According to the District's hydraulic model, the existing system can deliver the required fire flow. In order to provide this fire flow and receive service, you must construct a water line extension connecting to the 8-inch water line located in Runnymede Drive, approximately 600' west of the parcel to be developed. The 6-inch water line located in Runnymede Court is connected to a lower pressure zone and is not available to this project. The hydraulic grade line for the 8-inch water line located in Runnymede Drive is 1904 feet above mean sea level at static conditions and 1832 feet above mean sea level during fire flow and maximum day demands.

The flow predicted above was developed using a computer model and is not an actual field flow test.

### **Sewer Facilities**

There is an 8-inch sewer force main in El Dorado Road. This sewer line has adequate capacity at this time. In order to receive service from this line, an extension of facilities of adequate size must be constructed, as well as a District owned sewer lift station. The FPR should address sewer needs of this property and the surrounding area, including the design of the proposed sewer lift station.

### **Facility Plan Report**

A Facility Plan Report (FPR) will be required for this project. The FPR shall address the expansion of sewer facilities and potential properties to be served by a new lift station. A meeting to discuss the content of the report will be required. Please contact this office to arrange the meeting. A preliminary utility plan prepared by your engineer must be brought to the meeting.

Two copies of the FPR will be required along with a \$2,000.00 deposit. You will be billed for actual time spent in review and processing of your FPR. Please submit the FPR and fee to our Customer Service Department. Enclosed is the FPR description and transmittal form for your use. The items listed under content in the description and the completed transmittal form must be bound in each copy of the FPR.

### **Easement Requirements**

Proposed water lines, sewer lines and related facilities must be located within an easement accessible by conventional maintenance vehicles. When the water lines or sewer lines are within streets, they shall be located within the paved section of the roadway. No structures will be permitted within the easements of any existing or proposed facilities. The District must have unobstructed access to these easements at all times, and does not generally allow water or sewer facilities along lot lines.

Easements for any new District facilities constructed by this project must be granted to the District prior to District approval of water and/or sewer improvement plans, whether onsite or offsite. In addition, due to either nonexistent or prescriptive easements for some older facilities, any existing onsite District facilities that will remain in place after the development of this property must also have an easement granted to the District.

### **Environmental**

The County is the lead agency for environmental review of this project per Section 15051 of the California Environmental Quality Act Guidelines (CEQA). The County's environmental document should include a review of both offsite and onsite water and sewer facilities that may be constructed by this project. You may be requested to submit a copy of the County's environmental document to the District if your project involves significant off-site facilities. If the County's environmental document does not address all water and sewer facilities and they are not exempt from environmental review, a supplemental environmental document will be required. This document would be prepared by a consultant. It could require several months to prepare and you would be responsible for its cost.

### **Summary**

Service to this proposed development is contingent upon the following:

- ◆ The future availability of water supply
- ◆ Approval of the County's environmental document by the District (if requested)
- ◆ Approval of a Facility Plan Report by the District
- ◆ Approval of an extension of facilities application by the District
- ◆ Approval of facility improvement plans by the District
- ◆ Construction by the developer of all onsite and offsite proposed water and sewer facilities
- ◆ Acceptance of these facilities by the District
- ◆ Payment of all District connection costs

Services shall be provided in accordance with El Dorado Irrigation District Board Policies and Administrative Regulations, as amended from time-to-time. As they relate to conditions of and fees for extension of service, District Administrative Regulations will apply as of the date of a fully executed Extension of Facilities Agreement.




A substantial adverse effect to Visual Resources would result in the introduction of physical features that are not characteristic of the surrounding development, substantially change the natural landscape, or obstruct an identified public scenic vista.

- a) No identified public scenic vistas or designated scenic highway would be affected by this project. No impacts would occur.
- b) The proposed project would have no impact on existing scenic resources including, but not limited to, trees, rock outcroppings, and historic resources as the project is not located within a corridor defined as a State scenic highway.
- c) No development is proposed at this time. Future development of the site would require the submittal of a development plan application and further CEQA review. All proposed oak tree canopy removal would be consistent with General Plan Policy 7.4.4.4. No impacts would occur.

**Discussion:**

A substantial adverse effect to Agricultural Resources would occur if:

- There is a conversion of choice agricultural land to nonagricultural use, or impairment of the agricultural productivity of agricultural land;

- a) Review of the Important Farmland GIS map layer for El Dorado County developed under the Farmland Mapping and Monitoring Program indicates that no areas of Prime, Unique, or Farmland of Statewide Importance would be affected by the project. In addition, El Dorado County has established the Agricultural (-A) General Plan land use map for the project and included this overlay on the General Plan Land Use Maps. Review of the General Plan land use map for the project area indicates that there are no areas of "Prime Farmland" or properties designated as being within the Agricultural (-A) General Plan land use overlay district area adjacent to the project site. The project would not result in the conversion of farmland to non-agricultural uses.
- b) The proposed project would not conflict with existing agricultural zoning in the project vicinity and would not adversely impact any properties currently under a Williamson Act Contract. No impacts would occur.

**Discussion:**

A substantial adverse effect on Air Quality would occur if:

- Emissions of ROG and No<sub>x</sub>, will result in construction or operation emissions greater than 82lbs/day (See Table 5.2, of the El Dorado County Air Pollution Control District – CEQA Guide);
  - Emissions of PM<sub>10</sub>, CO, SO<sub>2</sub> and No<sub>x</sub>, as a result of construction or operation emissions, will result in ambient pollutant concentrations in excess of the applicable National or State Ambient Air Quality Standard (AAQS). Special standards for ozone, CO, and visibility apply in the Lake Tahoe Air Basin portion of the County; or
  - Emissions of toxic air contaminants cause cancer risk greater than 1 in 1 million (10 in 1 million if best available control technology for toxics is used) or a non-cancer Hazard Index greater than 1. In addition, the project must demonstrate compliance with all applicable District, State and U.S. EPA regulations governing toxic and hazardous emissions.
- a) The El Dorado County/California Clean Air Act Plan has set a schedule for implementing and funding Transportation Control Measures to limit mobile source emissions. The proposed project would not conflict with or obstruct the implementation of this plan as no development would occur prior to the approval of a development plan application which would require additional environmental review. No impacts would occur.

b & c)

Currently, El Dorado County is classed as being in "severe non-attainment" status for Federal and State ambient air quality standards for ozone (O<sub>3</sub>). Additionally, the County is classified as being in "non-attainment" status for particulate matter (PM<sub>10</sub>) under the State's standards. The California Clean Air Act of 1988 requires the County's air pollution control program to meet the State's ambient air quality standards. The El Dorado County Air Quality Management District (EDCAQMD) administers standard practices for stationary and point source air pollution control. Projected related air quality impacts are divided into two categories:

- Short-term impacts related to construction activities; and
- Long-term impacts related to the project operation.

An air quality analysis entitled "Air Quality Analysis for a General Plan Amendment and Rezone Associated with a Planned Mixed-Use Commercial/Residential Development in El Dorado County, CA" was submitted. However, "a quantitative analysis of project construction and operational emissions was not conducted because there is no project design at this phase of the project." (*Air Quality Analysis for a General Plan Amendment and Rezone Associated with a*

No impacts would occur.

- d) Although the air quality analysis identified several sensitive receptors such as schools, preschools, and health facilities within two miles of the project site, none of the sensitive receptors are within one mile of the subject site. As such, the proposed project would not expose sensitive receptors to substantial pollutant concentrations. Impacts would be less than significant.
- e) Table 3.1 of the CEQA Guide lists common types of facilities that are known to produce odors that potentially cause detriment, nuisance, or annoyance to the public. Mixed-use commercial/residential development is not listed as an odor generating facility. "Eventual build-out of the mixed-use commercial/residential development would not result in significant impacts resulting from odors." (*Air Quality Analysis for a General Plan Amendment and Rezone Associated with a Planned Mixed-Use Commercial/Residential Development in El Dorado County, CA, Sycamore Environmental Consultants, Inc., September 8, 2008*) Impacts would be less than significant.

**FINDING:** As discussed above, no development is proposed at this time. Future development at the subject site would be subject to the submittal of a supplemental air quality analysis to be prepared at time of development plan application submittal to analyze specific potential impacts from the proposed development plan. Impacts would less than significant.

**Discussion:**

A substantial adverse effect on Biological Resources would occur if the implementation of the project would:

- Substantially reduce or diminish habitat for native fish, wildlife or plants;
  - Cause a fish or wildlife population to drop below self-sustaining levels;
  - Threaten to eliminate a native plant or animal community;
  - Reduce the number or restrict the range of a rare or endangered plant or animal;
  - Substantially affect a rare or endangered species of animal or plant or the habitat of the species; or
  - Interfere substantially with the movement of any resident or migratory fish or wildlife species.
- a) A site-specific biotic assessment was completed by Sycamore Environmental Consultants, Inc. The study concluded that the project would have no impact on the California Red Legged Frog and Northwestern Pond Turtle. Additionally, “the project site does not provide habitat for any of the Pine Hill plants due to the lack of gabbro or serpentine derived soils and chaparral.” (*Biological Impact Analysis and Proposed Mitigation Measures for the El Mirage Plaza Project, El Dorado County, CA, Sycamore Environmental Consultants, Inc., January 12, 2009*) The project would be subject to the payment of mitigation area two rare plant fees prior to building permit issuance. As no development is proposed at this time, specific biological impacts would be further addressed at time of development plan application submittal. No impacts would occur.
- b) The project proposes no impacts to riparian habitat or other sensitive natural community identified in local or regional plans, policies, regulations, or by the California Department of Fish and Game or U.S. Fish and Wildlife Service. Future development at the subject site would require a 50 foot setback from Indian Creek. Specific potential impacts to Indian Creek would be analyzed at time of development plan application submittal. As no construction is proposed, no impacts would occur.
- c) There are two ephemeral channels, a seasonal wetland, an extension of a roadside ditch, and an intermittent stream (Indian Creek) at the project site. Indian Creek is subject to jurisdiction under Section 404 of the Clean Water Act. Ditches dug in uplands are not jurisdictional under Section 404 of the Clean Water Act. (*Biological Impact Analysis and Proposed Mitigation Measures for the El Mirage Plaza Project, El Dorado County, CA, Sycamore Environmental Consultants, Inc., January 12, 2009*) A commercial project could be built at the site without fill of Indian Creek. Specific potential impacts to Indian Creek and the other wetland features found at the project site would be analyzed at time of development plan application submittal. No impacts would occur.
- d) Review of the Planning Services GIS *Deer Ranges Map* (January 2002) indicates that there are no mapped deer migration corridors within the project site. No impacts would occur.
- e) The project would not conflict with any local policies or ordinances protecting biological resources, such as a tree preservation policy or ordinance. Future development of the subject site would require a discretionary planned development application with further CEQA review and would have the option of complying with either Option A or Option B of Policy 7.4.4.4. As no trees would be removed, no impacts would occur.
- f) The project would not conflict with the provisions of an adopted Habitat Conservation Plan, Natural Community Conservation Plan or other approved local, regional or state habitat conservation plan. There are no adopted habitat conservation plans or natural community conservation plans that are applicable to the project site. No impacts would occur.

The applicant submitted a "Cultural Resources Study of Assessor's Parcel No. 327-150-03 6480 Runnymede Drive, Placerville, El Dorado County, California 95667" prepared by Historic Resource Associates in September 2008. According to the study, "since no significant cultural properties were identified within the project area, no further cultural resource investigations are recommended." (*Cultural Resources Study of Assessor's Parcel No. 327-150-03 6480 Runnymede Drive, Placerville, El Dorado County, California 95667, Historic Resource Associates, September 2008*) No development is proposed at this time so no impacts would result for the proposed project. Future development would be subject to standard conditions of approval concerning cultural resource protection.

- c) A unique paleontological site would include a known area of fossil bearing rock strata. The project site does not contain any known paleontological sites or know fossil locales. No impacts would occur as no grading is proposed at this time.
- d) No construction is proposed at this time so no impacts would occur. For future development, in the event of the accidental discovery or recognition of any human remains in any location other than a dedicated cemetery, standard conditions concerning cultural resource protection would be implemented immediately.

**Discussion:**

A substantial adverse effect on Geologic Resources would occur if the implementation of the project would:

- Allow substantial development of structures or features in areas susceptible to seismically induced hazards such as groundshaking, liquefaction, seiche, and/or slope failure where the risk to people and property resulting from earthquakes could not be reduced through engineering and construction measures in accordance with regulations, codes, and professional standards;
- Allow substantial development in areas subject to landslides, slope failure, erosion, subsidence, settlement, and/or expansive soils where the risk to people and property resulting from such geologic hazards could not be reduced through engineering and construction measures in accordance with regulations, codes, and professional standards; or
- Allow substantial grading and construction activities in areas of known soil instability, steep slopes, or shallow depth to bedrock where such activities could result in accelerated erosion and sedimentation or exposure of people,

property, and/or wildlife to hazardous conditions (e.g., blasting) that could not be mitigated through engineering and construction measures in accordance with regulations, codes, and professional standards.

- a) According to the Fault Activity Map of California and Adjacent Areas (Jennings, 1994) and the Peak Acceleration from Maximum Credible Earthquakes in California (CDMG, 1992), no active faults or Earthquake Fault Zones (Special Studies Zones) are located on the project site. The impacts from fault ruptures, seismically induced ground shaking, or seismic ground failure or liquefaction are considered to be less than significant. Any potential impact caused by locating structures in the project area would be offset by the compliance with the Uniform Building Code earthquake standards. The project is not located in an area with significant topographic variation in slope. Therefore, the potential for mudslides or landslides is less than significant.
- b) No grading is proposed at this time. Future development would be subject to the submittal of a grading and drainage report as well as further environmental review. All proposed grading for future development must be in compliance with the El Dorado County Grading, Erosion, and Sediment Control Ordinance which would reduce any potentially significant impact to a less than significant level.
- c) As stated in the *Soil Survey of El Dorado Area, California, 1974*, the soils on the project site are primarily comprised of three soil types: Boomer gravelly loam (15 to 30 percent slopes), Boomer very rocky loam (30 to 50 percent slopes), and Mixed Alluvial Land. All future grading must be in compliance with the El Dorado County Grading, Erosion, and Sediment Control Ordinance which would reduce any potentially significant impact to a less than significant level.
- d) The erosion hazard for Boomer very rocky loam is high while the erosion hazard for Mixed Alluvial Land is moderate. Expansive soils would be further evaluated during review of the development plan application. Based upon this information, the impact from expansive soils would be less than significant.
- e) Public sewer service would be provided by the El Dorado Irrigation District as stated in a Facility Improvement Letter dated January 30, 2009 (*Facility Improvement Letter El Mirage Group, El Dorado Irrigation District, January 30, 2009*) Impacts would be less than significant.

**FINDING:** No significant impacts would result from geological or seismological anomalies on the project site as no grading is proposed at this time. The site does not contain expansive soils or other characteristics that would result in significant impacts. For the "Geology and Soils" category, established thresholds would not be exceeded by development of the project and no significant adverse environmental effects would result from the project.

**Discussion:**

A substantial adverse effect due to Hazards or Hazardous Materials would occur if implementation of the project would:

- Expose people and property to hazards associated with the use, storage, transport, and disposal of hazardous materials where the risk of such exposure could not be reduced through implementation of Federal, State, and local laws and regulations;
  - Expose people and property to risks associated with wildland fires where such risks could not be reduced through implementation of proper fuel management techniques, buffers and landscape setbacks, structural design features, and emergency access; or
  - Expose people to safety hazards as a result of former on-site mining operations.
- a) No significant amount of hazardous materials would be transported, used, or disposed of for the project. Future development of the subject site would require a discretionary planned development application with review by the El Dorado County Environmental Management Department for hazardous materials related issues. Impacts would be less than significant.
  - b) No significant amount of hazardous materials would be utilized for the project. Current County records indicate the subject site is not located within the Asbestos Review Area. Impacts would be less than significant.
  - c) As proposed, the project would not emit hazardous emissions or handle hazardous or acutely hazardous materials, substances, or waste within one-quarter mile of an existing or proposed school.
  - d) Significant disposal of hazardous waste has occurred within 2,000 feet of the subject site. Accordingly, the applicant would need to comply with the requirements of California Health and Safety Code Sections 25220-25241, including applying to the Department of Toxic Substances Control, prior to construction for a determination as to whether the land should be designated a hazardous waste property or border zone property pursuant to Health and Safety Code Section

2529. However, as no construction is proposed at this time, there would be a less than significant impact from hazardous material sites. Further CEQA review of this issue would be required upon submittal of the development plan application.

- e) *The San Francisco Sectional Aeronautical Chart*, last updated March 22, 2001, was reviewed and the project site is not located within two miles of a public airport. As such, the project would not be subject to any land use limitations contained within any adopted Comprehensive Land Use Plan. There would be no impacts to the project site resulting from public airport operations and the over-flight of aircraft in the vicinity of the project.
- f) *The San Francisco Sectional Aeronautical Chart*, last updated March 22, 2001, was reviewed and the project site is not located within two miles of a privately owned airstrip. As such, there is no significant safety hazard resulting from private airport operations and aircraft overflights in the vicinity of the project site. No impacts would occur.
- g) The proposed project would not physically interfere with the implementation of the County adopted emergency response and/or evacuation plan for the County. This is based upon the location of the nearest fire station, site access, availability of water for fire suppression, and provisions within the County emergency response plan. The County emergency response plan is located within the County Office of Emergency Services in the El Dorado County Government Center complex in Placerville. Impacts would be less than significant.
- h) No development is proposed at this time. Future development would require the submittal of a planned development application which would be reviewed at that time by the Diamond Springs - El Dorado Fire Protection District. As such, no impacts would occur.

**FINDING:** The proposed project would not expose people and property to hazards associated with the use, storage, transport and disposal of hazardous materials, and expose people and property to risks associated with wild land fires. For this "Hazards and Hazardous Materials" category, the thresholds of significance would not be exceeded. Future development would require the submittal of a discretionary planned development application and further environmental review to evaluate hazardous materials and fire safe issues.

**Discussion:**

A substantial adverse effect on Hydrology and Water Quality would occur if the implementation of the project would:

- Expose residents to flood hazards by being located within the 100-year floodplain as defined by the Federal Emergency Management Agency;
  - Cause substantial change in the rate and amount of surface runoff leaving the project site ultimately causing a substantial change in the amount of water in a stream, river or other waterway;
  - Substantially interfere with groundwater recharge;

Drainage impacts would be reviewed prior to development plan approval. No grading is proposed at this time. Therefore, substantial drainage pattern alteration or runoff would not occur. Impacts would be less than significant.

j) The proposed project is not located near a coastal area, and therefore, the project site would not be susceptible to tsunamis. No volcanoes or other active volcanic features are near the project site and, therefore, the project site would not be susceptible to mudflows. No impacts would occur.

**FINDING:** No significant hydrological impacts would result from development of the project. For the "Hydrology and Water Quality" section, it has been determined the project would not exceed the identified thresholds of significance and no significant adverse environmental effects would result from the project.

- Place a demand for library services in excess of available resources;

- a) **Fire Protection:** The Diamond Springs - El Dorado Fire Protection District currently provides fire protection services to the project area. The Diamond Springs - El Dorado Fire Protection District would review the development plan application prior to approval. Impacts would be less than significant.
- b) **Police Protection:** The project site would be served by the El Dorado County Sheriff's Department with a response time depending on the location of the nearest patrol vehicle. The minimum Sheriff's Department service standard is an 8-minute response to 80% of the population within Community Regions. No specific minimum level of service or response time was established for Rural Centers and Rural Regions. The Sheriff's Department stated goal is to achieve a ratio of one sworn officer per 1,000 residents. Impacts to response times would be analyzed at time of development plan application submittal and would require further CEQA review. Impacts would be less than significant.
- c) **Schools:** The project site is located within the Mother Lode Union School District. The affected school district was contacted as part of the initial consultation process and no comments were received. Impacts would be less than significant.

  - b) El Dorado Irrigation District provided a letter dated January 30, 2009 indicating that it has adequate water supplies and sewer facilities to serve the project. Therefore, no new or expanded off-site water or wastewater facilities would be necessary to serve the proposed project. Impacts would be less than significant.
  - c) All required drainage facilities for future development shall be built in conformance with the standards contained in the "County of El Dorado Drainage Manual," as determined by the Department of Transportation. No impacts would occur as no development is proposed at this time.
  - d) El Dorado Irrigation District provided a letter dated January 30, 2009 indicating that it has adequate water supplies to serve the project. Potential impacts from connecting to the existing 8-inch water line located in Runnymede Drive would be less than significant. Impacts would be less than significant.
  - e) The El Dorado Irrigation District provided a letter dated January 30, 2009 stating that there is an 8-inch sewer force main in El Dorado Road which has adequate capacity to serve the proposed project. (*Facility Improvement Letter El Mirage Group, El Dorado Irrigation District, January 30, 2009*) In order to receive service from this line, an extension of facilities of adequate size would need to be constructed, as well as a District owned sewer lift station. Therefore, the proposed project would not exceed water quality standards. Proposed sewer line extension impacts would be less than significant.
  - f) In December of 1996, direct public disposal into the Union Mine Disposal Site was discontinued and the Material Recovery Facility/Transfer Station was opened. Only certain inert waste materials (e.g., concrete, asphalt, etc.) may be dumped at the Union Mine Waste Disposal Site. All other materials that cannot be recycled are exported to the Lockwood Regional Landfill near Sparks, Nevada. In 1997, El Dorado County signed a 30-year contract with the Lockwood Landfill Facility for continued waste disposal services. The Lockwood Landfill has a remaining capacity of 43 million tons over the 655-acre site. Approximately six million tons of waste was deposited between 1979 and 1993. This equates to approximately 46,000 tons of waste per year for this period.

After July of 2006, El Dorado Disposal began distributing municipal solid waste to Forward Landfill in Stockton and Kiefer Landfill in Sacramento. Pursuant to El Dorado County Environmental Management Solid Waste Division staff, both facilities have sufficient capacity to serve the County. Recyclable materials are distributed to a facility in Benicia and green wastes are sent to a processing facility in Sacramento. Impacts would be less than significant.

- g) County Ordinance No. 4319 requires that new development provide areas for adequate, accessible, and convenient storing, collecting, and loading of solid waste and recyclables. On-site solid waste collection for the subject site would be handled through the local waste management contractor. Adequate space would be available at the site for solid waste collection. Impacts would be less than significant.

**FINDING:** No significant impacts would result to utility and service systems from development of the project. For the "Utilities and Service Systems" section, the thresholds of significance have not been exceeded and no significant environmental effects would result from the project.

**Discussion:**

- a) No construction or grading is proposed at this time so impacts would be less than significant. Further CEQA review would occur at time of development plan application submittal. Impacts would be less than significant.
- b) Cumulative impacts are defined in Section 15355 of the California Environmental Quality Act (CEQA) Guidelines as "two or more individual effects, which when considered together, would be considerable or which would compound or increase other environmental impacts." Based on the analysis in this study, it has been determined that the project would have a less than significant impact based on the issue of cumulative impacts.
- c) No construction or grading is proposed at this time so impacts would be less than significant. Further CEQA review would occur at time of development plan application submittal. Impacts would be less than significant.
