Re: 2009 Juvenile Accountability Block Grants (JABG) Funding

The Corrections Standards Authority (CSA) is pleased to announce the federal JABG funding for Fiscal Year (FY) 2009-10. As the direct allocation amounts for local jurisdictions have not been finalized, the federal Office of Juvenile Justice and Delinquency Prevention (OJJDP) has advised California to base its allocations on FY 2008-09 funding levels (see attached).

Attached to this letter is the FY 2009-10 application packet for those jurisdictions that are eligible to apply for a direct allocation. The application packet can also be accessed from the CSA website at www.cdcr.ca.gov/Divisions_Boards/CSA/.

The FY 2009-10 application follows a similar format as last year's application document. The funding cycle for this program is a 12-month period beginning July 1, 2009 and ending June 30, 2010.

As in previous years, a qualifying unit of local government may waive its right to a direct subgrant award and request that the funds be awarded to, and expended for its benefit by, a larger or contiguous unit of local government.

For FY 2008-09, grantees were asked to support California's efforts to expand the knowledge of Disproportionate Minority Contact (DMC) by attending training on DMC. This year California's State Advisory Committee on Juvenile Justice and Delinquency Prevention (SACJJDP), which oversees the use of federal funds administered by CSA, identified five priority areas in their Strategic Plan on which California will focus its efforts for the next three years. The five priority areas are: Alternatives to Detention; Disproportionate Minority Contact;

Evidence-Based Practices; Restorative Justice; and Holistic Approaches to Offender Counsel.

JABG discretionary funds have been identified by the SACJJDP and CSA to support the priority area of Evidence-Based Practices. Toward that end, the CSA has developed a "Best Practices Approach Initiative." The goal of this initiative is to assist probation departments and other JABG eligible recipients in developing and increasing their knowledge and use of best practices in the field of juvenile justice.

JABG recipients will have the opportunity to participate in a statewide training and comprehensive review of current validated risk/needs assessment tools and best practices that will be conducted in the coming year. Participation in these efforts will not affect your direct allocation this year; however, the SACJJDP plans to encourage JABG recipients to align the use of their direct allocation with goals that are identified in the SACJJDP's Strategic Plan for the future.

Additional information regarding the logistics of the statewide training and comprehensive review of assessment tools will be disseminated to all JABG during FY 2009-10.
