## AMENDMENT 1 TO AGREEMENT FOR LEGAL SERVICES BETWEEN EL DORADO COUNTY AND ABBOTT & KINDERMANN, INC. Agreement # 431-S1711 (Lunsmann)

This Amendment 1 to Agreement for Legal Services, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Abbott & Kindermann Inc., a California Professional Law Corporation, duly authorized to do business in the State of California, whose address is 2100 Twenty-First Street, Sacramento, CA 95818; (hereinafter referred to as "Law Firm"), for the performance of specific legal services for County;

## RECITALS

**WHEREAS**, County and Law Firm entered into an Agreement for Legal Services on February 14, 2016 ("Agreement"); and

**WHEREAS**, the parties hereto have mutually agreed to amend the compensation provision of the Agreement, **Section 2**, **Compensation**;

**NOW THEREFORE**, the parties do hereby mutually agree that the Agreement shall be amended as follows:

**SECTION 2, Compensation,** shall be amended to read as follows:

2. Compensation. In consideration of the services set forth in paragraph 1, the County shall pay the Law Firm on an hourly rate in accordance with the billing rates set forth on Exhibit A, "Abbott & Kindermann, Inc. Rate Schedule." Law Firm shall keep proper records to enable County to verify the services rendered, and such records shall be made reasonably available to County or its agents for inspection and audit. William Abbott will be the attorney primarily responsible for the services to be provided under this agreement. The Law Firm may utilize the services of other attorneys or staff as deemed appropriate and efficient; provided, that such other persons shall be under the supervision of Mr. Abbott. The County and Law Firm acknowledge that there are a wide range of factors that will influence the total compensation for work performed pursuant to this Agreement. Funds budgeted for the purposes of this Agreement are made available on a fiscal year basis, and budgeting is subject to change at any time. Compensation under this Agreement shall not exceed \$125,000.

Except a specifically amended herein, all remaining sections and terms of Agreement for Legal Services shall remain in full force and effect. This Amendment 1, which may be executed in counterparts, is deemed effective on the date executed by all parties.
