Good Morning Judi,

This is a follow-up to your invitation yesterday to attend today's Board meeting.

Nancy Kerry, the City's Housing Manager, will be able to attend this afternoon's meeting of the Board of Supervisors and provide information to the Board regarding this foreclosure-assistance program available to the County and City. This is one of those opportunities where there are no County or City funds required. The Federal government provides the State Department of Housing and Community Development with funds that are then disbursed to eligible entities. Because of the fine work of Ms. Kerry, we learned of our collective eligibility to receive these funds if we file a joint application. The beneficiaries are people wanting to get into homes and the opportunity is to get people back into foreclosed properties and properties on the tax role. Bringing in over \$1.4 million to the County and City in assistance dollars has to help our economies as well... an added benefit.

As I mentioned to you, I am not available to attend this afternoon's meeting. I am working on agenda items for next week's City Council. I would like to visit a Board meeting in person sometime in the near future just to observe and become more familiar with our County government.

I appreciate the support provided by Supervisor Santiago for the program and for the invitation to attend today's meeting. Allowing foreclosed properties to return to occupancy is a good program and one that will help us to make a difference as government during these difficult financial times. It is also an opportunity for us to work together as local governments to serve our common constituency.
