ARTICLE XIV
Indemnity: The Comstltant shall defend, indemnify, and hold the County harmless against and from any and atl elaims, suits, lesses, damages and liability for damages of every name, kind and deseription, including attorneys fees and wosts inemfed, brought for, or on account of, injuries to or death of any person, including but not limited to workers, County employees, and the public, or damage to property, of any economic or consequential lowses, whieh-are chamed to or in any waty arise out of or are comnected with the Consultant's surviees, operations, or performanse hereunder, regandless of the existence or degree of fatht-or negligence-on the part of the Gemty, the Consultant, subconsultant(s) and employee(s) of any of these, uweept for the sole, or active negligente of the Comaty, its officers and employees, or axpressly preseribed by stattle. This duty of Consultant to indemnify and sitve County hamless includes the duties to delent set forth in Galifornia Civil Code Seetion 2778.
