RE: Northern California Construction Training Contract #3106

I have attached agreement 3106, which you had previously approved. Unfortunately, after your approval, the department had a change to the NTE amount of the contract to increase the contract to \$224,150.27 (previously \$198,287.00). This change reflected the admin costs being charged on a monthly basis as the vendor had not included that in the original monthly total.

Additionally, we added clarification on the exhibit that the instructor wages and benefit totals are set by the Union and changed the materials costs to an annual amount of \$12,000 with an approximate value of \$1,000 per month.
