#### AGREEMENT FOR SERVICES #281-F1811

### AMENDMENT I

This Amendment I to that Agreement for Services #281-F1811, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "CONTRACTOR") and El Dorado County Office of Education, a public agency, whose principal place of business is 6767 Green Valley Road, Placerville, California 95667 (hereinafter referred to as "EDCOE"), each being a "Party" and collectively the "Parties".

### RECITALS

WHEREAS, EDCOE is the Fiscal Agent for the First 5 CA IMPACT Grant which supports High 5 for Quality and requires professional services of providing the "Early Literacy on the Move" (ELOM) program for child care providers and Alternative Sites consistent with First 5 CA IMPACT guidelines and CONTRACTOR is qualified and desires to provide the ELOM program, in accordance with Agreement for Services #281-F1811, dated December 5, 2017, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have an existing Agreement #168-O1811 to provide funding for supplies to be given to child care providers who are participating in the ELOM program; and

**WHEREAS**, the Parties have agreed to automatically terminate Agreement #168-1811 upon execution of this Amendment I; and

**WHEREAS**, the parties hereto have mutually agreed to incorporate the services from the existing Agreement #168-O1811, into this Agreement hereby amending **Section A – SCOPE OF WORK**; and

**WHEREAS,** the parties hereto have mutually agreed to increase the total amount of this Agreement by \$36,000 for a new not-to-exceed amount of \$180,000, hereby amending **Section C – FISCAL REQUIREMENTS: FEE SCHEDULE**.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #281-F1811 shall be amended a first time as follows:

## A. SCOPE OF WORK – Section A. 1. c) i) is hereby replaced in its entirety as follows:

- c) Rate of Pay
- i) 17-18 Annual Budget amount not to exceed budget of \$48,000 consistent with the budget in Attachment 2, less the expenses incurred and invoiced to First 5 El Dorado between July 1, 2017 and December 31, 2017 as documented by six month (July 1, 2017- December 31, 2017) budget expenditure form verified by First 5 El Dorado. The 18-19 Annual Budget amount not to exceed \$66,000 and a three year budget not to exceed \$180,000 less expenses incurred and invoiced to First 5 El Dorado between July 1, 2017 and December 31, 2017.

## A. SCOPE OF WORK is hereby amended to add a new Section A.2 to read as follows:

- 2. EDCOE agrees to pay CONTRACTOR for the cost of items, materials and supplies for the ELOM program as follows:
- a) CONTRACTOR, in its sole discretion, will select and order items from vendors to support and enhance child care provider visits from Library staff.
  - b) CONTRACTOR will receive items and pay invoices promptly.
- c) CONTRACTOR will provide 1) copies of invoices; 2) packing slips; and 3) report of all expenditures to EDCOE quarterly (October 15, January 15, April 15, and July 15).
- d) EDCOE will reimburse CONTRACTOR for submitted invoices within thirty (30) days of receipt.
- e) Total amount for the cost of items, materials and supplies for the ELOM program shall not exceed \$13,000 per year.

# Section C – FISCAL REQUIREMENTS: FEE SCHEDULE: Paragraph 1, first sentence, is hereby replaced in its entirety as follows:

For services outlined above, EDCOE agrees to pay the CONTRACTOR up to \$180,000, over the contract period.
