
This Fourth Addendum, to the Fixed Base Operator (FBO) Lease Agreement ("Lease Agreement") entered into on October 24, 1989 and Assigned in or about July of 1999 ("Assignment"), by and between the COUNTY OF EL DORADO, a political subdivision of the State of California, hereinafter called COUNTY, and Scott P. Herring, d.b.a., AirFilm Camera Systems, a CALIFORNIA LLC, hereinafter called LESSEE, entered into this of, 2009.
WHEREAS, the parties entered into a FBO Lease Agreement for the use of the premises at the Georgetown Airport (AIRPORT) for the purpose of operating as a FBO; and
WHEREAS, LESSEE desires to rent the County Hangar CH 01 for the remaining term of the FBO Lease, the location of which is shown on Exhibit E, which is attached hereto and incorporated herein by reference, and LESSEE desires to add to and amend the terms of the Lease Agreement as specified.
NOW, THEREFORE, it is mutually agreed as follows:
1. Section 2, LEASED PREMISES, add a second paragraph to the Lease Agreement to read as follows:
COUNTY hereby grants to LESSEE permission to conduct those commercial aeronautical activities described in the Assignment at said AIRPORT in County Hangar CH 01 for the operation of a FBO, depicted on Exhibit E (herein after referred to as the leased premises), which is attached hereto and incorporated herein by reference. LESSEE recognizes that electrical and communication equipment for the AIRPORT operation is in said hangar and LESSEE shall allow COUNTY access at any time to equipment for installation, maintenance, and repair.
2. Section 4, CONSIDERATION, add line (5) to paragraph b to the Lease Agreement to read as follows:
(5) The consideration for use of the County Hangar CH 01 shall be Five Hundred Twenty Five Dollars (\$525.00) per month.
3. In all other respects the terms and conditions of the Lease Agreement and Assignment shall remain in full force and effect.
