(\*) Such writings and communications to include any handwriting, typing, printing, photocopying, transmitting by facsimile or electronic mail, any form of communication or representation including letters, words, pictures, sounds or symbols, or combination thereof, and any record thereby created, regardless of the manner in which the record has been stored.

The agency must justify the withholding of any record by demonstrating that the record is exempt or that the public interest in confidentiality outweighs the public interest in disclosure. (§6255) If you determine that some but not all of the information is exempt from disclosure and that you intend to withhold it, I ask that you provide a signed notification citing the specific legal authorities on whom you rely.

To avoid unnecessary delays or costs of duplication, electronic copies are acceptable and may be emailed to melody.lane@reagan.com in a compressed file format. Access is always free. Fees for "inspection" or "processing" are prohibited. (§ 6253)

It is requested that your determination be made within 10 days as stipulated within the California Public Records Act, Government Code 6253(c).

#### CALIFORNIA BROWN ACT

#### PREAMBLE:

"The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people do not yield their sovereignty to the bodies that serve them. The people insist on remaining informed to retain control over the legislative bodies they have created."

#### CHAPTER V.

#### RIGHTS OF THE PUBLIC

\$54954.3 Public's right to testify at meetings. (c) The legislative body of a local agency shall not prohibit public criticism of the policies, procedures, programs, or services of the agency, or of the acts or omissions of the legislative body. Nothing in this subdivision shall confer any privilege or protection for expression beyond that otherwise provided by law. Care must be given to avoid violating the speech rights of speakers by suppressing opinions relevant to the business of the body.

As such, members of the public have broad constitutional rights to comment on any subject relating to the business of the governmental body. Any attempt to restrict the content of such speech must be narrowly tailored to effectuate a compelling state interest. Specifically, the courts found that policies that prohibited members of the public from criticizing school district employees were unconstitutional. (Leventhal v. Vista Unified School Dist. (1997) 973 F. Supp. 951; Baca v. Moreno Valley Unified School Dist. (1996) 936 F. Supp. 719.) These decisions found that prohibiting critical comments was a form of viewpoint discrimination and that such a prohibition promoted discussion artificially geared toward praising (and maintaining) the status quo, thereby foreclosing meaningful public dialog.

Where a member of the public raises an issue which has not yet come before the legislative body, the item <u>may be briefly discussed</u> but no action may be taken at that meeting. The purpose of the discussion is to permit a member of the public to raise an issue or problem with the legislative body or to permit the legislative body to provide information to the public, provide direction to its staff, or schedule the matter for a future meeting. (§ 54954.2(a).)

<u>Caltrans' Practices, with Words of Encouragement and Thanks</u>

The past few weeks, I suspect, have been inordinately trying for more than a few people here today, but I hope not unexpectedly. After all, given Caltran's and the State of California's long history of often disregarding the needs and best interests of small-town and rural Northern California, it should come as no surprise that Caltrans has once again used shadowy tactics, and is employing 'bulldozer' methods to do what it was planning to do since day 1 on the U.S. Highway 50 Camino Safety Project — a charade that since it's administrative approval in late 2015 has cost El Dorado County government "untold" tens of thousands of dollars in staff time, and will leave the many people and families who live along the Highway 50 corridor in the uphill and 5 to 6 square-mile area of where the project will be done with the consequences of an illconceived, costly fiasco that will have significant adverse effects on many of their lives and will likely cost El Dorado County tens of millions of dollars over time to deal with, if it ever can.

Meanwhile, Caltrans (unwittingly I suppose) has yet again done overt damage to its long-endangered credibility as a transportatation agency that can be fully trusted to work effectively with either county or municipal governments, or the stakeholders it

purports to serve. As frequently stated in the 2014 reports on Caltrans done by the State Smart Transportation Initiative, at the behest of the Governor, Caltrans ever since its founding in 1972, like its predecessors, has been fixated on building and expanding freeways, its way, and only its way — and "to hell with the consequences."

That said, there are reasons to be encouraged by the history of the Highway 50 Camino Safety Project, as recently decided but not yet started. For starters, the SSTI report, if properly 'put in play,' provides a potentially useful lever for extracting tangible concessions from Caltrans upper management, if not soon, then in the very near future, given its claimed liking for the SSTI report and what I suspect is the Governor's growing realization that it's on-target recommendations are not being implemented, as intended, at the district level.

As for thanks, I want to express my gratitude for all the hard work done by Chairman Ranalli, and especially by Supervisor Veerkamp over the past years, to make the Camino Highway 50 safety project not harmful. That your efforts did not result in the hoped-for outcome, while frustrating, should in no way be viewed as a defeat, but as a setback in pursuit of a worth-while cause. It's a cause worth fighting for again — soon!
