
T. CCIL Open Firm BOS alk Izar

Subject: Email Access

Good afternoon Ms. Lane,

Over the last few months, you have sent numerous emails, sometimes including lengthy email chains and/or attachments along with your communication. These emails have included in their distribution numerous staff members in addition to Department Heads, my office, the offices of the Board of Supervisors and their assistants.

The County's email system is designed to make County operations more effective and efficient. In furtherance of that objective the County has a practice of limiting certain types of email traffic. The County has never by policy or practice opened its email system for indiscriminate use by the general public.

The County takes seriously its obligation to provide the constituents of the County with access to their local government, however, the County's email system is not a traditional public forum nor has the County designated it as such. As a nonpublic forum, the County can impose reasonable regulations on the use of its email system. In fact, even where a public forum is involved, the law allows reasonable time, place, and manner restrictions upon the use of that public forum. As has been noted "Freedom of expression does not mean that everyone with opinions or beliefs to express may do so at any time and place..." It has also been recognized that the government and the taxpayers its serves have a substantial interest in avoiding unnecessary drains upon the public resources. By sending these lengthy emails with extensive attachments to numerous County employees and officials, public resources are diverted from other important tasks when those employees and officials must open and review the email and attachments.

This is to let you know that effective immediately the County is restricting your ability to email County staff. In order to ensure you continue to have access to your local government, you will still be permitted to email all Board of Supervisors members, their assistants, County Department Heads as well as edc.cob@edcgov.us and planning@edcgov.us. You remain free to express any opinions, requests, or other comments in your emails as the County has no interest in restricting your ability express your viewpoint on matters of County governance.

We appreciate your interest in the operation of your local government and trust you understand that we share your desire to ensure that the County operates effectively and efficiently for all of the citizens of the County.

Pat and Duane,

As you heard during the Taxpayers meeting, the CL News is run by American River Conservancy, an extremely hostile and liberal environmental NGO known for their opposition to conservative values and Constitutional governance. The CLNews Steering Committee, often referred to as the River Mafia Mob, includes but is not limited to Alan Ehrgott, Mike Bean, Howard Penn, Donna McMaster, and CLFSC reps Deborah Kruse &Tim Kulton. They all work in conjunction with CA State Parks and El Dorado county staff.

FYI, Donna McMaster hasn't lived within CA for approximately 15 years. Ranger Bill Deitchman is one of three CSP rangers currently under investigation for misconduct. Deborah Kruse & Tim Kulton admit to being members of ARC. The attached photos and CPRA were submitted along with other relevant documents to Jim Mitrisin during the 9/11 BOS Agenda Item #30 – ARC land acquisitions, but Jim deliberately failed to post them to the minutes as required by law. That was the agenda item where the entire BOS walked out of the room under the direction of Consigliere Mike Ciccozzi when they had no authority whatsoever to do so.

The inter-related issues involve multiple arson fires, threats, assaults, shootings, hacking, identity theft, pornography, harassment, libel, slander, trespassing, eminent domain, control of watershed acreage, and failure to lawfully respond to CPRAs. We've had multiple meetings with state and county staff over these topics, all to no avail. Consequently Mike Ranalli, Shiva Frentzen, Al Hamilton, Gary Miller, Roger Trout, Don Ashton, Bill Schultz, and Assemblyman Frank Bigelow have received notifications of their legal responsibility which is the first essential of due process of law.

During the 9/5/18 Mt. Murphy Bridge meeting held at Gold Trail Grange Hall, several people expressed their concerns about egress in the event of yet another arson fire on historic Mt. Murphy. Including staff, there were exactly 50 people in the room. Additionally several residents indicated they were never contacted or provided a Right of Entry Consent form for the CLFSC project work. When Supervisor Ranalli and county staff refused to address our public safety concerns, some residents abruptly exited the building in anger due to their lack of transparency or accountability.

Subsequently on 9/7/18 I posted the following message to CLNews which was also addressed to you, Duane Nelson, Mike Ranalli and CA State Parks staff:

I just spoke with Project Manager Duane Nelson about an hour ago. He is already doing project work on Robinson's property. However Fire Safe clearing on Mt. Murphy Road isn't supposed to commence until 9/11.


Apparently certain residents are being given preferential treatment, whereas several of us still haven't received notice, nor were we provided the necessary consent forms. Duane indicated he'd bring this to the attention of the CLFSC, but

again, it would be most helpful if you'd appropriately respond via CLNews as to how and where can ALL residents obtain the Consent Forms for this CLFSC project??

Several residents expressed similar concerns during the Mt. Murphy Bridge replacement meeting held at Grange Hall on Wednesday evening. Construction of the new bridge may not be completed for 4 – 6 years. Meanwhile annual fireworks at the Coloma Resort, excessive traffic, egress problems and deplorable road conditions could prove disastrous in the event of yet another Mt. Murphy fire. For the record, Supervisor Ranalli was reluctant to appropriately answer direct questions in regard to our public safety concerns.

On September 13th I received the below message from the CLNews Steering Committee. The Mob falsely claimed I broke their 'rules' therefore they 'voted' to suspend my posting 'privileges' to CLNews. Their targeted retaliation was for exposing their highly unethical tactics during the 9/11 BOS meeting. CONTRARY TO THEIR CLAIMS, I HAVE NEVER INAPPROPRIATELY POSTED ANYTHING TO CLNEWS!!!

On Friday 9/21 I noticed a sign posted at the intersection of Carvers & Mt. Murphy Roads. From 8 feet away it was totally illegible, so I took another picture just two feet from the sign printed in small font. Apparently the project is again delayed until 9/24, yet several of my neighbors still haven't obtained a ROE form in order to participate in the CL Fire Safe project work.





Pat, there is no excuse for your rude behavior during the Taxpayers meeting last week when you reluctantly provided me the three Fire Safe contracts. Several questions and concerns remain about their content.

When you have knowledge of wrongdoing and fail to take remedial action, then you become complicit and liable. You're either part of the problem, or part of the solution. Which is it going to be?

Melody,

Your three messages to the CL News group, sent September 2 and September 7, 2018, were in violation of the CL News Guidelines that were posted to the list and also shared with you directly in August. As a result, the CL News Steering Committee has voted to suspend your posting privileges for CL News for six months. During this time you will be able to read messages from the list but will be unable to post to the list.

The CL News Guidelines, which are posted at

https://groups.google.com/d/msg/clnews/VU6Goo6gfGo/Eye3qHt1BQAJ, state:

"CL News is also NOT to be used to post negative comments or commentaries about people, whether they are inside or outside the community. Calling people derogatory names has no place on the list. Turning a conversation on the list into an attack on another group member is the quickest way to be removed from the list."

Your messages criticized the volunteers on the local Coloma Lotus Fire Safe Council, as well as the EDC Fire Safe Council, the project manager, and Supervisor Ranalli, along with multiple complaints aimed at no specific party. If you have criticisms, they should be directed at the specific individuals or groups, not to the list. If you had posted just one message, it might have been ignored, but multiple messages hammering on local parties could not be tolerated. We received numerous complaints from list members asking that your behavior be stopped.

This is your second infraction. After the six months you will be reinstated but you will still be on probation. A third infraction will result in complete removal from CL News for a 12 month period. After 12 months, you may petition the Steering Committee in writing to be reinstated. Reinstatement is not guaranteed, & each situation will be reviewed individually.

We will be writing a separate email to the group and to list administrator Mike Bean to inform them of this decision.

You are welcome to reply to this message if you do not understand why, or would like to express an opinion about the Guidelines or this decision. Please be polite.


What It Involves
