# HIGH PERFORMANCE - COLD PATCH MIX - WEST SLOPE

<u>General:</u> The El Dorado County Procurement & Contracts Division is requesting bids for the purchase of high performance cold patch mix to be purchased on an "as requested" basis for thirty-six months (36-months) following the bid award. Prices shall remain firm for the awarded period unless all conditions of the escalation clause have been met, see page six (6). The quantity indicated on Quotation Schedule is an estimated annual usage; the County makes no guarantee as to the total amount to be purchased during the awarded period. Contract period to begin approximately December 1, 2018.

**Specifications:** The Director of Transportation, or authorized personnel, may reject furnished material not meeting specifications contained in this Invitation to Bid.

This material shall be composed of a modified bituminous liquid blend and suitable laboratory approved crushed aggregates. It shall be plant or pugmill mixed, available in bulk or bags and capable of storage in an uncovered outdoor stockpile for a minimum of six (6) months. The material shall be capable of repairing asphalt and concrete pavements in all-weather applications. The mixture will be firm and workable in a temperature range between 0 degrees F and 100 degrees F. Product samples may be requested during the evaluation process.

Requirement: Material must be available for purchase during all twelve months of the year.

### ALL BIDS SHALL BE QUOTED FREIGHT PREPAID FOB DESTINATION

Prior to preparing your bid submittal, please note the General Terms and Conditions, Instructions to Bidders, Item #3 which states: Erasures, overwrites and the use of correction fluid or tape are NOT acceptable.

Bidders shall direct all inquiries to the County Procurement and Contracts Division Purchasing Agent and shall not contact the requesting department directly regarding any matter related to this Invitation to Bid.

**Delivery:** The Community Development Agency – Department of Transportation County vehicles will pickup the bulk material from the vendor's plant location, bagged material will be picked up or delivered to 2441 Headington Road, Placerville, CA 95667.

<u>California Sales & Use Tax Requirement</u>: Any bidders located outside of the State of California selling goods to the County must possess a valid and current California Seller's Permit at the time of bidding and maintain such permit in good standing throughout the awarded period.

**Incomplete and Altered Bids:** Incomplete or altered bids, and bids containing items not called for in the bid may be rejected. Bids submitted on forms other than those furnished by the County will not be considered.

<u>Terms and Conditions</u>: The County will not consider any terms and conditions other than the terms and conditions contained in the subject bid. Bidders submitting their own terms and conditions will not be considered and will be rejected. Any bid response containing alterations to the General Terms and Conditions or terms and conditions contained in the subject bid, will not be considered and will be rejected.

<u>Merchantability</u>: There shall be an implied warranty of merchantability and fitness of an intended use. Any bid submittals taking exception to this requirement may, at the County's option, be considered nonresponsive.

<u>County's Rights</u>: The Purchasing Agent reserves the right to not enter into any agreement, cancel this process at any time, amend this process at any time, or to award more than one contract to the lowest, responsive, responsible bidders if it is in the best interest of the County

**<u>Pricing:</u>** Bid prices shall remain firm for the awarded thirty-six month (36-month) period. In case of default by the awarded vendor, the County may procure the product from another source and may recover the loss by legal process. Please refer to the "General Terms and Conditions," under "Award," Item #9.

**Escalation Clause:** Price increases from the manufacturer to the successful vendor may be passed on during the life of this bid only when the following conditions are met: (1) Vendor must submit notification to the Procurement & Contracts Division of the price increase along with a new updated vendor's price list; (2) Proof of the price increase from the manufacturer shall be provided to the Procurement & Contracts Division prior to any increase being approved; and (3) Price increase(s) shall commence seven (7) days after the approval and acceptance from the Purchasing Agent. Acceptance of the price increase(s) shall be in writing signed by the Purchasing Agent.

### HIGH PERFORMANCE - COLD PATCH MIX - WEST SLOPE

### Category "A": Bulk County Pick-Up of High Performance Cold Patch Mix at Vendors Location.

Bids shall be evaluated by determining low material cost, plus total costs to County for hauling. Hauling costs will be determined using the round trip hauling rate of \$1.67 per mile and assuming an average load size of ten (10) tons.

Example: 50-mile round trip with an average load size of 12 tons per load.

50 miles x 1.67 per mile = \$83.50 per round trip/load 204 tons (est. annual usage) / 12 ton per load = 17 loads Hauling costs: \$83.50 per trip/load x 17 loads = \$1,419.50
